- (a) *the percentage of increase in the prices of various food items in the country since January, 2009;*
- (b) *the steps being taken by the Government to control the increase in prices of food items?*

Mr. Nazar Muhammad Gondal: (a) The prices of some major food items since January, 2009 to date have increased with the following percentages:—

- (b) Government has taken the following steps to control the prices of these food items:
1. Currently ban is imposed on export of wheat to ensure supply to the common man on affordable price.
 2. Allowed import of raw and refined sugar in private sector as well as TCP to check escalation of sugar price.
 3. Arranged supply of sugar through Utility Stores at subsidized rates.
 4. Supply of ghee at Utility Store Corporation of Pakistan (USC).
 5. For import substitution of edible oil, Palm oil and Olive Plantation is being encouraged. Other oil seed crops like Canola and Sunflower have been focused further to increase local production.
 6. Free movement of agriculture commodities including wheat has been allowed across Provincial frontiers. A credit line was set up for private sector for building of storage and commodity procurement.
 7. Government decided to allow import of wheat and wheat flour by the private sector according to the specifications prescribed by the Ministry of Food and Agriculture.

8. Support price of wheat for 2008-09 crop was raised from Rs.625 to Rs. 950 per 40 Kg which has resulted in record crop, easing the supply position of wheat in the country.
9. A procurement target of 6,550,000 tons of wheat was fixed, against which 9,123,942 tons have been procured by the public sector up to 08-06-2009.
10. Government has allowed duty free import of essential items including pulses from regional countries.
11. Government through PASSCO procured Gram and Mung pulses as buffer stocks to stabilize prices of these pulses in the Market. During 2006-07 following quantities of Gram and Mung were procured.

- (c) *the names of doctors and other staff working in the said satellite hospital; and*
- (d) *the measures envisaged to make that hospital useful and effective for the residents of the area?*

Mir Aijaz Hussain Jakhrani: (a) Only one component of NIH (Hospital Wing) was handed over to PIMS on 01-02-2005 for running its un-utilized Indoor facilities and up-grading the emergency services for 24 hours alongwith diagnostic services to rural population of surrounding areas. The services available there are as under:—

- (i) Indoor patients.
- (ii) Emergency Department.
- (iii) X-Ray Department.
- (iv) Diagnostic facilities *i.e.* CTG machine, ECG, Ultrasound, multi purpose ultrasound unit for physiotherapy and new Nebulizer for asthmatic patients for management of Allergy Centre.
- (v) Gynae/Ante-natal OPD.

- (vi) Physiotherapy Department.
- (vii) EPI Centre.
- (viii) Family Planning Centre.
- (ix) Animal Bite Treatment Centre.

(b) No separate budget is allocated. The expenditure is met from PIMS annual allocation.

(c) The names of doctors and other staff working in PIMS Satellite Hospital is given in Annex-A.

(d) PIMS Satellite Hospital was upgraded after February, 2005 by PIMS to make it fully functional as 50 bedded Indoor as well as Outdoor facility alongwith 24 hours emergency care services for surrounding rural population of ICT, NIH employees and their families.

58. ***Mr. Muhammad Talha Mahmood:** (Notice received on 04-05-2009 at 11:20 a.m.)

Will the Minister for Foreign Affairs be pleased to state:

(a) *the details of controversial issues between Pakistan and India; and*

(b) *the steps being taken by the Government to resolve those issues?*

Makhdoom Shah Mehmood Qureshi: (a) and (b) Composite Dialogue between Pakistan and India was resumed in 2004. The fifth round was launched by the Foreign Secretaries of the two countries on 21 July 2008 in New Delhi. In the wake of Mumbai incident of November 2008 India has placed a “pause” on the Composite Dialogue.

Major controversial issues between Pakistan and India are as under:

1. **Jammu and Kashmir dispute**

Pakistan’s principled position on Jammu and Kashmir dispute is based on the UN Security Council Resolutions, which provide that the final disposition of Jammu and Kashmir will be made in accordance with the will of the people to be determined through a free and impartial plebiscite under the UN auspices. Pakistan is committed to this position. The issue has been discussed during five rounds of Composite dialogue. The last Foreign Secretary level talks on Jammu and Kashmir under the 5th Round of the Composite Dialogue process was held on July 21, 2008 in New Delhi. An important development was the decision to commence cross-LoC trade on the Srinagar-Muzaffarabad and Poonch-Rawalakot routes from 21 October 2008. Resolution of the Kashmir dispute holds the key to durable peace in the region which is an essential pre-requisite for the economic uplift of South Asia and prosperity of its people. Pakistan maintains that the people of Kashmir should be associated with the dialogue process between Pakistan and India.

2. **Siachen and Sir Creek**

The Siachen glacier is situated near the north-eastern tip of Baltistan and forms part of the Northern Areas. Strategically, it lies to the north of the terminus of the Line of Control (NJ 9842) which was also the terminus of the Cease Fire Line of 1949 and of the agreement on the Line of Control of 1972. Since 1947, this area has been controlled and administered by Pakistan as part of its Northern Areas. India moved its troops in Siachen in April 1984. In order to forestall further incursions by the Indians, Pakistani troops took up positions in the area.

The first round of Defence Secretary-level talks on Siachen was held in January 1986. Since then, 11 rounds of talks have been held between the two countries. The matter has also been discussed at various levels during bilateral meetings. Several ideas have been exchanged for the resolution of the issue. However, no progress has been made due to India's insistence on authentication by Pakistan of the Actual Ground Position Line.

Similarly the Sir Creek issue has been discussed between Pakistan and India intermittently from 1976 -2004 but failed to reach a decision. The issue is being discussed under Composite dialogue process. During the review meetings of the Fourth round (21 May 2008), EAM Mukherjee remarked that "Sir Creek was close to a resolution" in response to the emphasis by the Foreign Minister regarding its "doability".

3. **Water Issues**

Under the provisions of Indus Waters Treaty, the waters of three Western Rivers, namely Indus, Jhelum and Chenab, have been allocated to Pakistan. Under the Indus Waters Treaty (1960), restrictions have been placed on the design and the operation of hydroelectric plants, storage works and other river works to be constructed by India on the Western Rivers. The Treaty provides a procedure for the settlement of differences and disputes. Any question, which arises between the parties, is to be first examined by the Commission. If the Commission fails to resolve the issue, either Commissioner can initiate action to resolve the issue through Neutral Expert/Court of Arbitration. Questions of technical nature are to be dealt with by a Neutral Expert whereas other questions are to be settled through a Court of Arbitration. Construction of water reservoirs by India in violation of the Indus Waters Treaty is a matter of great concern for us. It is important to adhere to the Indus Water Treaty in letter and spirit to reach a just resolution to the water disputes. Resolution of the Water issues is extremely important.

59. ***Mr. Wasim Sajjad:** (Notice received on 04-05-2009 at 12:25 p.m.)

Will the Minister for Foreign Affairs be pleased to state:

- (a) *whether it is a fact that sixteen Pakistanis have been sentenced by a court in Yemen, if so, the charges framed against the said persons and the sentence awarded to each of them;*

- (b) *the details of legal assistance provided/being provided by the Pakistan Embassy in Yemen to those persons during their trials and in their appeals to higher courts;*
- (c) *whether any interpreter was provided to those persons by the Pakistan Embassy in Yemen before, during and after their trial; and*
- (d) *the steps being taken by the Government to expedite the hearing of appeals, if any, of the said persons in higher courts?*

Makhdoom Shah Mehmood Qureshi: (a) Yes. Out of the sixteen Pakistanis, the Yemeni Court awarded death sentence to one Mr. Khuda Bakhsh and 25 years imprisonment to the rest of fifteen individuals on the charges of smuggling of drugs to Yemen;

(b) Embassy of Pakistan, Sana'a hired the services of a lawyer for defending the cases of these Pakistani nationals in the First Instance Court. The lawyer will file an appeal before the Appellate Court;

(c) An interpreter has been provided by the Mission; and

(d) The lawyer hired for the purpose is in the process of submitting an appeal in the Appellate Court.

61. ***Haji Ghulam Ali:** (Notice received on 06-05-2009 at 15:05 p.m.)

Will the Minister for Industries and Production be pleased to state;

- (a) *whether it is a fact that the Prime Minister has recently directed to regularize the services of all daily wages employees of the Utility Stores Corporation, if so, the steps taken by the Government in this regard; and*

Mian Manzoor Ahmad Wattoo: (a) No such direction has been received from the Prime Minister Secretariat.

(b) After the induction of requisite manpower on contract basis, the surplus daily wage employees have been relieved from service and they have been paid accordingly. However, necessary data/information is being collected from USC Regional/Zonal offices to confirm that dues of all ex-daily wage employees have been cleared.

Mr. Muhammad Azam Khan Swati: (a) I. Realizing the need and importance of Metrology, Standards, Testing and Quality assurance, Government of Pakistan established Pakistan Standards and Quality Control Authority (PSQCA) under the Act VI 1996 (under the administrative control of this Ministry).

II. PSQCA have developed a mechanism for ensuring the quality of products both for mandatory as well as voluntary conformance. It has formulated National standards and also adopted ISO/IEC national standards as Pakistan standards on various items particularly food items and other consumer items / products. PSQCA has so far formulated / adopted 28081 Pakistan standards. 78 of these standards have been notified as mandatory standards which mainly relate to food and safety. The manufacture and sale of these has to conform to laid down Pakistan standards for which samples are taken from industry and also from open market as per laid down procedure and tested at Quality Control Centre (QCC) of PSQCA and from other laboratories recognized by PSQCA for conformance with Pakistan Standard Specifications.
