**Nawabzada Khawaja Muhammad Khan Hoti:** (a) The quantity and estimated value of narcotics seized in the country since January, 2007 to 30th November, 2008 is attached as Annex-A.

(b) The narcotics are disposed off by burning through drug burning ceremony at the earliest, after decision by the CNS Court.

Decision for disposal of drugs burning is obtained from concerned CNS Special Court and the responsibility of sampling of drugs is assigned to a judicial magistrate by the concerned Court. Therefore, a drug burning ceremony is held in the presence of concerned Judges/Magistrates, which is attended by dignitaries/Government functionaries and judiciary. Concerned judges also sign the drug burning certificates/memo.

**“UN-STARRED QUESTION AND ITS REPLY”**

**For Friday, the 24th July, 2009**

1. **Prof. Khurshid Ahmed:** (Notice received on 24-06-2009 at 09:25 a.m.)

*Will the Minister for Railways be pleased to state:*

- (a) *whether it is a fact that Mr. Muhammad Nadeem & Co. were given a contract for lifting of contract material etc. on Khanpur Chacharan Section of Sukkur Division:*
- (b) *whether it is also a fact that Mr. Nadeem and other employees of the Company were reportedly involved in the stealing of scrap material from the said area and as such the said contract was cancelled;*
- (c) *whether it is also a fact that FIR. 18/2000 dated 27-01-2000 under section 379-PPC was lodged against the aforementioned Company and Mr. Nadeem and others were arrested; and*
- (d) *whether it is further a fact that contract of company has been restored, if so, why and under what conditions?*

**Haji Ghulam Ahmad Bilour:** (a) It is a fact that M/s. Muhammad Nadeem and Co. were awarded the contract on 06-04-1999 for lifting of contract material etc. on Khanpur-Chacharan section of Sukkur Division, being the highest bidder.

(b) When the contractor dismantled and lifted 4 KMs of track a ban on the sale of Railway scrap was imposed. However, the contractor dismantled and tried to lift another 2 Kms of track for which a FIR was lodged against him. In retaliation he filed a suit against Railways in Civil Court, Lahore.

(c) FIR No.18/2000 dated 31-12-1999 was registered at Zahir Pir Police Station by PWI Khanpur against M/s. Muhammad Nadeem etc. for lifting of 2 KM length of track material without depositing the cost. The case was entrusted to DPO Rahim Yar Khan for further proceeding.

(d) The matter was subjudice in the court of law since 2001 and fresh tendering was not possible in face of court's injunction. Railway track material was also being pilfered by thieves and criminal, therefore it was through judicious to allow the existing contractor to lift the remaining material which could benefit. Railway financially. The case was revived again so that remaining material could be disposed off which was being stolen.

The concerned authorities have been asked to safeguard Railways interest in every respect to the maximum advantage of Railways before restoration of the sale order.
