*Will the Minister for Health be pleased to state:*

- (a) *the amount spent by the National Tuberculosis control Programme on the construction and maintenance of its offices in Islamabad and on purchase of various items for those offices since 1st May, 2008; and*
- (b) *the names of the firms/contractors to whom contracts were awarded for the said works/jobs indicating also the amount of tender and the amount so paid and the time by which balance amount will be paid?*

**Mir Aijaz Hussain Jakhrani:** (a) No amount has been spent by National TB Control Programme in Islamabad on construction and maintenance of its offices as the same are presently housed in a rented building. Since 1st May, 2008 the programme purchased 20 computers and 19 furniture items costing Rs.785,680/- & Rs.98,141/- respectively.

**Mir Aijaz Hussain Jakhrani:** (a) During the last three years 297 drugs (Annexure A) were banned and registrations were cancelled on the basis of safety, efficacy and quality.

Repair and Maintenance cost is being met by the Ministry. An amount of Rs. 43477/- is spent on its repair, maintenance and fuel.

**Mian Manzoor Ahmad Wattoo:** (a) There are 1552 industrial units established so far in NWFP and 66129 workers are employed therein.

(b) There are 702 sick/closed industrial units and 20230 workers have been affected due to their closure.

**Mir Aijaz Hussain Jakhriani:** (a) The building of Sheikh Khalifa Bin Zayyed, Federal Hospital, Quetta was completed by UAE Government in 1998.

(b) The hospital has been functioning since April, 2007 for out door patients. In door patient facility will be operationalized when equipment is received.

(c) Approved cost of PC-I is Rs. 497.220 million out of which funds released to the hospital during last three years are as follows:—

**Mr. Nazar Muhammad Gondal:** (a) The steps taken by the present government to enhance per acre yield of various crops and to achieve self-reliance in agricultural outputs are mentioned at Annexure-I, along with the achievements gained thereupon.

(b) There are two principle agricultural research institutes of federal government which include Pakistan Agricultural Research Council (PARC), Islamabad and Pakistan Central Cotton Committee (PCCC), Karachi Achievements of PARC & PCCC are attached at Annexure-II & III respectively.

67. **\*Prof. Khurshid Ahmed:** (Notice received on 08-07-2009 at 14:20 p.m.)

*Will the Minister for Food and Agriculture be pleased to state:*

- (a) *the quantity of wheat produced in the country during the years 2008 and 2009;*
- (b) *the quantity of wheat imported during the said period; and*
- (c) *the steps taken by the Government to achieve self-reliance in wheat production?*

**Mr. Nazar Muhammad Gondal:** (a) Wheat production during 2007-08 was 21 million tones while according to the 2nd estimates (received from the provinces) wheat production for year 2008 – 2009 is 23.420 million tonnes.

(b) Wheat imports during 2007-08 were 1.7 million tonnes and in 2008-09 2.6 millions tones.

(c) To achieve the self-reliance in wheat production, Government has taken the following steps:—

- (i) The Guaranteed Minimum Price (GMP) of wheat for 2008-09 was increased to Rs. 950/- per 40 kgs.
- (ii) Target of 6.5 million tones of wheat was fixed for procurement by the public sector.
- (iii) Government increased the subsidy on fertilizer to the tune of Rs.32 billion and also removed GST on fertilizer and pesticides.
- (iv) Ensured timely availability of inputs like seed, fertilizer and pesticides/herbicides. The supply of Agri. Credit to farmers was also increased.
- (v) The farmers were advised for judicious use of water and micro-management of irrigation water at local level through active coordination of Irrigation and Agriculture Departments.
- (vi) Under Grow More Wheat Campaigns Federal/Provincial Agriculture Departments disseminated information to the growers through electronic and print media on production technology of wheat crop. Provincial Agriculture Departments also educated the farmers at the field level regarding bringing more area under wheat and adoption of good agricultural practices for increasing wheat productivity.
