**Ms. Hina Rabbani Khar:** World Bank has provided technical assistance of US\$ 60 million for Social Safety Nets Technical Assistance Project on July 03, 2009, in order to enhance the capacity of the government to bring the poor into the social safety nets, strengthen the safety net programme, enforce a monitoring mechanism and reinforce procedures for effective implementation of the safety net programme through evaluation, better management and transparency.

A loan of US\$ 200 million has also been negotiated with the World Bank as Social Protection Development Policy Credit, which is awaiting approval of Board of World Bank.

**Minister Incharge of the Establishment Division:** (a) National School of Public Policy (NSPP) was established under Ordinance No.XCIX of 2002. The general direction and administration of the affairs of the School vests in the Board of Governors, chaired by the President of Pakistan. The School being a body corporate, is competent to determine teaching methods and strategies as well as co-curricular activities in order to ensure the most effective educational and other related programmes. The Executive Committee of BOG, therefore, decided to discontinue NIPA course at four provincial headquarters due to the following reasons:—

- (i) a new course called Mid Career Management Course (MCMC) for BS-18 officers was introduced for which larger space was required. Premises of former NIPAs at Karachi, Peshawar and Quetta are now being utilized for conducting MCMC.
- (ii) no uniform method of course evaluation, for the entire group of BS-19 officers, was followed at former NIPAs located at four provincial headquarters.
- (iii) faculty and guest speakers of desired qualifications and experience to train such officers are not always available at Karachi, Quetta and Peshawar.
- (iv) providing opportunities of national integration amongst participants under-going NIPA course at one location.
- (v) The formulation of course modules and syllabi was left to the discretion of the respective Director Generals of the former NIPAs.

(b) Five months Senior Management Course was introduced at Lahore due to the following reasons:—

- (i) to ensure standardization of course curriculum and syllabi.
- (ii) to ensure uniformity and justice in training evaluation of the officers and completion of training programmes.
- (iii) to harness qualified and experienced faculty and guest speakers mostly available at Lahore.

(c) The Senior Management Course will in future be held at Islamabad after shifting of NSPP Headquarters, for-which land has been acquired.

The reasons for not promoting the officers of Income Tax Group are that no additional posts have been created in BS-20 since 1980.

- (iv) Allotment of 7 plots cancelled.
- (v) 219 cases pending in the Civil/High Courts.
