55. ***Dr. Muhammad Ismail Buledi:** (Notice received on 21-11-2009 at 09:45 a.m.)

Will the Minister for Religious Affairs be pleased to state:

- (a) *the number of persons sent on Hajj through regular and private schemes during the last three years and current year with province-wise break up; and*
- (b) *the details of the Hajj Quota enhanced by the Government of Saudi Arabia for Pakistan during the said period and the mode of its distribution?*

Syed Hamid Saeed Kazmi: (a) I. Province-wise breakup, in respect of Regular Hajj Scheme, is as under:—

34. ***Moulana Gul Naseeb Khan:** (Notice received on 23-01-2010 at 09:05 a.m.)

Will the Minister for Petroleum and Natural Resources be pleased to state whether there is any proposal under consideration of the Government to supply natural gas to district Dir, if so, its details?

Syed Naveed Qamar: Yes, there is a proposal to supply gas to Lower Dir as per following details:—

- ◆ The Government has approved supply of gas to Chakdara and Talash including Gulabad and Ouch in district Dir.
- ◆ Total cost of the project is Rs.516.82 million (Rs.307.66 million will be borne by the company and Rs.209.16 million by the Government).
- ◆ The Government has released its share of Rs.209.16 million in November, 2009.
- ◆ The detailed designing for laying of transmission spur alongwith land acquisition is in progress and it is anticipated that the project will commence by December, 2010, barring unforeseen circumstances.

36. ***Dr. Khalid Mehmood Soomro:** (Notice received on 25-01-2010 at 10:20 a.m.)

Will the Minister for Petroleum and Natural Resources be pleased to refer to Senate Starred question No. 62, replied on 13th January, 2010 and state:

- (a) *the daily, monthly and annual income from each oil and gas fields in Sindh; and*
- (b) *the number of persons working on the said fields with province-wise and district-wise breakup?*

Syed Naveed Qamar: (a) Detailed information on parts (a) and (b) of the question is given at Annex-I.

37. ***Hafiz Rashid Ahmad:** (Notice received on 25-01-2010 at 11:25 a.m.)

Will the Minister for Religious Affairs be pleased to state:

- (a) *the amount of rent charged from pilgrims for tents in Mina during Hajj, 2009;*
- (b) *whether it is a fact that a number of pilgrims of Maktab No.59 were not provided tents despite payment of the rent, if so, its reasons;*
- (c) *whether it is also a fact that the officers of Pakistan Hajj Mission, Makkah did not respond to complaints of the pilgrims of the said maktab, if so, the action to be taken against the officers concerned; and*
- (d) *whether there is any proposal under consideration of the Government to refund the amount of rent of tents to those pilgrims, if not, its reasons?*

Syed Hamid Saeed Kazmi: (a) The amount of tent charges deducted from pilgrims is as follows:—

1. SR 390/- for old Mina;
OR
2. SR 300/- for new Mina. (as the case may be)

(b) A Complaint and information cell was established at Pakistan Hajj Mission at Mina and Makkah Mukarramah. No complaint for non-provision of tents by Maktab No.59 was received. Even after completion of Hajj 2009, no such complaint has been received in the Ministry.

(c) As no complaint was received from the pilgrims of the said Maktab, therefore, the question for taking action against officers of Pakistan Hajj Mission does not arise.

(d) In view of the position, as explained above, no such proposal is under consideration.

38. ***Hafiz Rashid Ahmad:** (Notice received on 25-01-2010 at 11:25 a.m.)

Will the Minister for Religious Affairs be pleased to state:

- (a) *the procedure laid down for hiring buildings for pilgrims in Makkah and Madina;*
- (b) *whether it is a fact that some of buildings hired for the Hajj 2009 were without basic necessities including Alkaram Place in Madina;*
- (c) *the number of complaints lodged in Pakistan Hajj Mission and the action taken thereon; and*
- (d) *whether there is any proposal under consideration of the Government to take action against the officers involved in the process, if so, its details?*

Syed Hamid Saeed Kazmi: (a) Following procedure for hiring of Buildings was observed:—

- o Hiring may be done by observing codal formalities on first come first serve basis.
- o The buildings consistently rated FR (Fine recommended) and (Recommended) in the previous year may be hired.
- o The determination of rent in Makkah Mukarramah may be based on quality of building and distance from the Haram having rent not more than SR.3200/- per pilgrim;
- o Accommodation in Madina Munawwarah may be hired from Accommodation Groups at SR.400 per pilgrim per cycle, to be paid on actual occupancy basis within 1,000 meters.

(b) As per Saudi law, no Building can be hired without basic necessities. There are two buildings namely 'Fundaq Al-Karam and 'Qasr Al-Karam' in Madina Munawwarah.

- I. Fundaq Al-Karam: It is three star Hotel in Central Area (Markazia) at a distance of 250 meters from the boundary wall of Haram.
- II. Qasr Al-Karam: It is one of the best buildings rated by the committee in B+ category, located out side Markazia at a distance of 710 meters in locality of Hashmia having capacity of 207 pilgrims. Bath pressure is 6.08 persons. It was offered by Al Massah group. No complaint has been lodged by the pilgrims against this building as per record of Pak Hajj Mission Madina Munawwarah.

(c) 45 general complaints in Pre-Hajj and 16 complaints in Post Hajj periods relating to buildings were received and disposed off to the satisfaction of the Hujjaj.

(d) As all complaints were disposed off to the satisfaction of Hujjaj, therefore, question for taking action against officers of Pakistan Hajj Mission does not arise.

39. *Mst. Afia Zia: (Notice received on 25-01-2010 at 12:10 p.m.)

Will the Minister Incharge of the Prime Minister's Secretariat be pleased to state:

- (a) *the details of development schemes proposed for new Balakot city; and*
- (b) *the number of the said schemes on which work has been started?*

Minister Incharge of the Prime Minister's Secretariat: (a) There are a total of 17x proposed development schemes for New Balakot City is Annexed.

(b) Work on 5 schemes *i.e.* basic infrastructure facilities (Water Supply, Sewerage System, Drainage System, Culverts, Bridges and Roads), has been started.

40. *Mst. Afia Zia: (Notice received on 25-01-2010 at 12:10 p.m.)

Will the Minister Incharge of the Prime Minister's Secretariat be pleased to state whether there is any proposal under consideration of the Government to provide plots or accommodation to the earthquake affectees of Balakot in new Balakot city, if so, the procedure and criteria laid down in this regard?

Minister Incharge of the Prime Minister's Secretariat: (a) Yes, there is a proposal under consideration by the Government of Pakistan to provide **Plots** to the Earthquake Affectees of Balakot (Red Zone) in New Balakot City. The procedure adopted for allotment of plots is based on survey carried out by Union Council Nazims, Representatives of Local Community, NESPAK and District Administration. The criteria set as per ERRRA strategy is that the plots will be allotted to the owner's of houses living in Red Zone of Old Balakot Town.

Will the Minister for Petroleum and Natural Resources be pleased to state the names and designation of the officers of Sui Northern Gas Pipelines Limited sent abroad on official visits during the last three years indicating also the purpose of visit and ,amount spent in each case?

Syed Naveed Qamar: Names and designation of the officers of Sui Northern Gas Pipelines Limited sent abroad on official visits during the last three years including the purpose of visit and amount spent year-wise in each case is at Annexure-I.

Will the Minister for Petroleum and Natural Resources be pleased to state whether it is a fact that natural gas has not been supplied to the adjacent areas of Gurguri and Makori gas fields including Tehsil Hangu, if so, whether there is any proposal under consideration of the Government to supply gas to those areas, if so, when?

Syed Naveed Qamar: No, in-fact SNGPL is providing gas to adjacent areas of Gurguri and Makori gas fields, including that of Tehsil Hangu.

44. ***Mr. Muhammad Idrees Khan Safi:** (Notice received on 26-01-2010 at 15:00 p.m.)

Will the Minister for Petroleum and Natural Resources be pleased to state whether there is any proposal under consideration of the Government to supply natural Gas to Burma Town, Jabba, Pendorian, New Shakarial and Sowan (Rural Areas of Islamabad), if so, when?

Syed Naveed Qamar: Currently, there is no plan to supply gas to Burma Town, Jabba, Pendorian, New Shakarial and Sowan due to financial and physical constraints faced by the Gas Company and the huge gap between gas demand and supply.

Will the Minister for Petroleum and Natural Resources be pleased to state:

- (a) the percentage of decrease in the oil prices in international market from September 2008 to January 2009;*
- (b) the percentage of decrease in oil prices in Pakistan during the said period; and*
- (c) whether there is any proposal under consideration of the Government to decrease the oil prices in Pakistan in accordance with decreased prices in international market, if so, when?*

Syed Naveed Qamar: (a) The percentage of average decrease in oil prices in international market from September 2008 to January 2009 is as under:—
