Will the Minister for Housing and Works be pleased to state the names and names of departments of the persons who have been allotted Government accommodations in Islamabad on out of turn basis since January, 2001 indicating also the address of accommodation and the name of authority on whose recommendation the allotment has been made in each case?

Mr. Noor-ul-Haq Qadri: The amount of Zakat Fund released to the Provinces during the financial years 2008-09 and 2009-10 (upto 30-06-2010) is as under:

Will the Minister for Religious Affairs be pleased to state whether there is any proposal under consideration of the Government to hire local Khudamul Hujajj of Muatamir Alami Islami instead of sending them from Pakistan during Hajj, if so, its details?

Syed Hamid Saeed Kazmi: No such proposal is under consideration of the Government. However, 250 persons are recruited as local Khuddam-ul-Hujjaj in Saudi Arabia. They are generally Pakistani students, studying in various educational institutions in Saudi Arabia. They speak Arabic fluently and are well aware of the Saudi rules, regulations and location of building/areas.

160. ***Begum Najma Hameed:** (Notice received on 28-05-2010 at 09:00 a.m.)

Will the Minister Incharge of the Prime Minister's Secretariat be pleased to state:

- (a) *the number of effectees of the earthquake of 8th October, 2005 who have been provided financial assistance by ERRA so far for construction of their houses; and*
- (b) *the criteria and procedure adopted for provision of the said assistance?*

Minister Incharge of the Prime Minister's Secretariat: (a) So far, ERRA has provided financial assistance to **564,334** affectees of the earthquake of 8th October, 2005 for construction of their houses.

(b) **Criteria and Procedure:**To assess the losses caused by the earthquake of 8th October, 2005, ERRA constituted **Assistance and Inspection Teams (AITs)** comprising civil and military personnel, who conducted house to house survey in the field and categorized the damaged houses as under:

- (i) **Partially Damaged: 101,091** houses fall in this category. Besides initial payment of Rs. 25,000/- each of these partially damaged houses was eligible to receive a further payment of Rs. 50,000/-
- (ii) **Completely Damaged: 463,243** houses fall in this category. After initial payment of Rs. 25,000/- each house was eligible to receive 2nd, 3rd and 4th tranche of Rs. 75,000/- Rs. 25,000/- and Rs. 50,000/- respectively, subject to plinth and lintel level inspection regarding construction of the house as per ERRA design.

Will the Minister for Youth Affairs be pleased to state:

- (a) *the number of persons sent abroad on official visits / tours by the Ministry of Youth Affairs during the last two years indicating also the amount spent on those visits with head-wise break up; and*
- (b) *the names of persons sent by the Ministry of Youth Affairs to China in May, 2010 with province-wise break-up?*

Mr. Shahid Hussain Bhutto: (a) 393 persons were sent abroad on official visits/tours by the Ministry of Youth Affairs during the last two years. The list of amount spent on those visits with head-wise breakup is attached as Annex-I.

(b) The list of persons sent by the Ministry of Youth Affairs to China in May, 2010 with province-wise break-up is attached as Annex-II.

- (i) Facilitation of bilateral agreement between the Government of Kingdom of Saudi Arabia and Government of Pakistan for each Hajj.
- (ii) Implementation of the agreement.
- (iii) Coordination for purpose of implementation/execution of Hajj arrangements with different departments.
- (iv) To provide welfare services including medical care to Hajj pilgrims at Jeddah Airport, Makkah Mukarramah and Madinah Munawwarah.

(b) The details of persons working in the Directorate General of Hajj, Jeddah, Makkah Mukarramah and Madinah Munawwarah are at Annex-A, B and C.
