3. Accordingly, the Standing Committee on National Food Security & Research considered the matter in its meeting held on 2nd March, 2016.

4. As informed by PARC & CDA officers in the meeting, the matter was listed in the hon'ble Supreme Court of Pakistan on 13.01.2016 in which, the learned Counsel for CDA has sought time to place the matter before the board so that the decision could be taken in consonance or otherwise of the recommendations of the Senate Standing Committee on National Food Security and Research. The request for short adjournment was allowed and it was directed to relist the matter in the second week of February, 2016. In the meantime the interim arrangement already made by the Court would remain operative.

5. The officers further informed that a notice was thereafter received from the Director, Supreme Court of Pakistan on 18.01.2016 informing that the case has been fixed for hearing on 10.02.2016. Another notice was received on 09.02.2016 wherein it was mentioned that due to the non availability of regular bench of Hon'ble Chief Justice at Islamabad the case has been relisted and new date for its succession would be communicated later on. No fresh notice for the next date of hearing has been issued.

6. The Chairman PARC also stated that the position in relation to the 1400 acres of land continues to be same and the possession is with the PARC.

7. The report is submitted to the Senate as per the directions of the Chairman of the Senate.
