
6. The Mover Senator Sardar Muhammad Azam Khan Musakhel along with Senator Muhammad Usman Khan Kakar and the affectees, was present in the meeting. The Chairman, Standing Committee on Defence recapped that the point of order raised by Senator Sardar Muhammad Azam Khan Musakhel was taken in the last meeting of Defcom held on 08.02.2017. It was decided that a Sub-Committee constituted under the Convenership of Senator Lt. Gen. (R) Abdul Qayyum with Senator Muhammad Javed Abbasi and Senator Maulana Ata-ur-Rehman as its members. Senator Sardar Muhammad Azam Khan Musakhel and Senator Muhammad Usman Khan Kakaras Special Invitees. The Sub- Committee was to submit its report within a period of two months. The Sub- Committee was to submit its report within a period of two months. The Sub-Committee twice postponed the site visit, first due to placement of "Military Courts Bill" before the House. The second visit was postponed on the request of Ministry of Defence due to census being held in Balochistan.

7. The Committee decided that a meeting in the first week of May, 2017 will be convened in the Parliament House on the one point agenda to resolve this issue. The Secretary Defence would coordinate with Station Commander, Loralai and ensure his presence in the next meeting of the Committee to resolve the issue amicably. The Committee further recommended that Senator Lt. Gen. (R) Abdul Qayyum may also coordinate with the Corps Headquarters at Quetta to resolve this issue in public interest.

8. The Chairman DEFCOM & the Senate Standing Committee on Defence adopted this report and approved its laying before the August House.
