REPORT OF THE SENATE STANDING COMMITTEE ON COMMUNICATIONS ON STARRED QUESTION NO. 151 ASKED BY SENATOR AHMED HASSAN, REFERRED BY THE HOUSE TO THE STANDING COMMITTEE ON COMMUNICATIONS IN ITS SITTING HELD ON 26TH JANUARY, 2018

- I, Senator Muhammad Daud Khan Achakzai, Advocate, Chairman of the Standing Committee on Communications, have the honour to present a report of the Committee on Question No. 151 asked by Senator Ahmed Hassan regarding the details of the project for construction of Bajour (Khar)- Jandola-Zhob Road, and referred to the Committee for consideration and report.

- 4. The Committee considered and discussed the subject issue in its meeting held on 2nd March, 2018. The Committee was informed that after the directions of the Honourable Prime Minister, the feasibility study for the construction of Bajour-Znob link road was conducted in consultation with FATA Secretariat. The representatives of Ministry apprised the Committee on the salient features of the project including road design parameter and cross falls i.e. the 933 Km total length of road, 205 Km length of Zhob-Jhandola section. The Secretary, Ministry of Communications also

apprised the Committee regarding NHA standards and specifications. He assured the Committee that the tentative date for completion of feasibility study and preliminary design of the total length of road is June, 2018 and similarly, tentative date for preparation of PC-I is 15th July, 2018.

- 5. After detailed deliberation, The Committee disposed of the matter with the following recommendation / direction.
 - ➤ The Secretary, Ministry of Communications in collaboration with NHA may ensure the completion of feasibility study and preliminary design of the 933 Km total length of road till June, 2018.
 - ➤ The Secretary, Ministry of Communications in collaboration with NHA may undertake the construction work of 205 Km length of Zhob-Jhondola section from July, 2018.
