One serious consequence would be that it would allow India with the capability to cause acute water shortage in Pakistan. It could deprive Pakistan upto 8000 cusecs of water per day. The Senate of Pakistan therefore urges upon India to suspend its work immediately on this Dam till the Government of Pakistan is satisfied that the construction of this Dam is not against the Indus Water Treaty and the interest of Pakistan."
