- Question No. 75 regarding the quantity and value (in pak rupees) of medicine/ vaccines being imported from India on monthly basis was moved by Senator Rehman Malik. The matter was discussed in the meeting of the Committee held on 12th July 2019 which was initially referred to the Committee on 26-04-2019. The Ministry provided its detailed response. But the Mover was not satisfied in the last meeting. In the meeting held on 29th July, 2019, Senator Abdul Rehman Malik forwarded some amendments in relevant laws along with proposals which were referred to the Ministry.
- 5. Finally in the meeting held on 20th August 2019 the mover of the Question No. 75 Senator Abdul Rehman Malik gave very valid proposals to be adopted by National Health Services Regulation & Coordination that the Ministry should direct the Pharmaceutical Industries to produce at least 5% of the medicine/vaccines which are being imported from India on monthly basis. The pharmaceutical companies are hundreds in number which can produce not only the required volumes of medicines/vaccines for the country but we can export plenty of medicines/vaccines to those countries who are not producing such medicines/vaccines. By this way our reliance on India in this time of bilateral tension will be reduced to zero. And the import burden of around 15 Million Dollar per year will be over. On the other hand we can earn millions of Dollar from the export of such medicine/vaccines.
- 6. The committee has directed the ministry to formulate some rules in line with the above proposal and report back to the Senate Standing Committee on NHSR&C through notification of formulation of the relevant rules, for the pharmaceutical companies.
