

REVISED NOTICE

Reference Senate Secretariat's notice of even number dated 14th October, 2019. The meeting of the Senate Standing Committee on National Food Security & Research scheduled to be held on 23rd October, 2019 at 11:00 a.m. in Committee Room No. 4, Parliament House, Islamabad (in case of Senate session in the morning will be held at 02:00 p.m.) **The date and time of the said meeting will remain the same, however, the revised agenda before the Committee would be as under:-**

- i. The Ministry of National Food Security and Research to submit a report on the progress in relation to indicative price of cotton for the Khareef Season, 2019 and the present position of cotton crop and what would be the estimated production of cotton in the year 2019 and the reasons for the shortfall.
 - ii. The Pakistan Central Cotton Committee (PCCC) to submit a report about the present position of cotton crop during Khareef 2019, especially in Sindh where there was acute shortage of water and adverse weather condition.
 - iii. The PARC to submit a report on the progress of filling up vacancies of all grades in PARC and its attached department indicating latest position.
 - iv. The PASSCO to submit a report on the progress made for procurement of land for construction of godown in District Umerkot (Sindh).
 - v. The Indus River System Authority (IRSA) to brief the Committee on availability of water in Indus River for the Rabbi Season, 2019.
 - vi. Briefing by the Ministry on the updated position of the PARC's project "Malakand Agricultural Research Institute (MARI)" at Lower Dir, with Research Station at Chitral, Swat and Malakand Districts".
 - vii. **The Zarai Taraqati Bank Limited (ZTBL) to inform the Committee about the details of schemes available for agriculture credit.**
 - viii. The Ministry of National Food Security & Research to submit a report on the following: -
 - a. Letter of the President Chamber of Commerce & Industry Quetta (Balochistan) regarding sale of wheat to Mill owners belonging to Balochistan Province.
 - b. Letter of the President Chamber of Commerce & Industry Peshawar (Khyber Pakhtunkhwa) regarding Wheat Supply to all Provinces of Pakistan on equality basis.
 - ix. Any other item with permission of the Chair.
