CALLING ATTENTION NOTICES

SENATOR KALSOOM PERVEEN, drew attention of the Minister for Interior towards the forcible acquisition of land in Mozahs Tamma and Mohrian of District Islamabad against the will of the land owners which may create law and order situation.

Mr. Ali Muhammad Khan, Minister of State for Parliamentary Affairs made statement and the Calling Attention Notice was referred to Standing Committee concern.

Motion under Rule 263

Senator Mohammad Azam Khan Swati moved under rule 263 of the Rules of Procedure and Conduct of Business in the Senate, 2012, that the requirements of rule 183 of the said Rules be dispensed with in order to enable the Committee on Delegated Legislation to constitute more than one sub-committee. The sub-committees will not be liable to dissolution at the expiration of two months. However, the main Committee or the Chairman Senate may dissolve any subcommittee whenever deem appropriate.

BILL TO BE INTRODUCED

Mr. Muhammad Hamad Azhar, Minister of State for Revenue on behalf of Dr. Khalid Maqbool Siddiqui, Minister for Information Technology and Telecommunication, introduced the Bill further to amend the Prevention of Electronic Crimes Act, 2016 [The Prevention of Electronic Crimes (Amendment) Bill, 2018].
