CONSIDERATION OF ADMISSIBILITY OF ADJOURNMENT MOTIONS

Admissibility of the following Adjournment Motion was determined:-

Senator Col. (R) Syed Tahir Hussain Mashhadi moved Adj. Motion No. 1(3-267/2017-M) to discuss the lack of beds for patients and other medical equipment in Pakistan Institute of Medical Sciences (PIMS) and Federal Government Services Hospital (FGSH), Islamabad.

After hearing the Mover, the Chairman held the Motion in Order and fixed it for two hours discussion.

CALLING ATTENTION NOTICE

Senator Dr. Jehanzeb Jamaldini, drew attention of the Minister for Finance, Revenue and Economic Affairs towards the closure of Phase-II of automation project of National Savings by the end of September, 2017 due to which three hundred employees engaged in this project, having expertise in the relevant field, might lose their jobs whose services can be utilized in Phase-III of the said project proposed to be initiated in near future.

DISCUSSION ON THE ADMITTED ADJOURNMENT MOTION

Discussion on the admitted adjournment motion moved by Senator Sehar Kamran on 20th September, 2017, regarding the reported reconstitution of Council of Common Interests by the Prime Minister was to be made in the House but the Chairman disposed of the adjournment motion due to the reasons that the subject matter of the motion is found to be based on misconception so no cause of action accrues, therefore, no need to discuss the same in the House.
