Senator Farhatullah Babar, Chairman, Select Committee on the Right to Information Bill, 2016, moved under sub-rule (1) of rule 194 of the Rules of Procedure and Conduct of Business in the Senate, 2012, that the time for presentation of report of the Committee on the Bill to provide for the right to information in a rapid and low-cost manner subject only to reasonable restrictions established by law [The Right to Information Bill, 2016], introduced by Senator Kamil Ali Agha on 21st November, 2016, may be extended for a period of thirty working days with effect from 19th March, 2017.

The Motion was put to the House and the requisite extension was granted.

MINISTERIAL RESPONSE BY THE MINISTER

Mr. Muhammad Baligh ur Rehman, Minister of State for Interior and Narcotics made statements on the following points of public importance:-

- 1. Regarding the various incidents of ransacking of Christian localities in various parts of the country on the pretext of various allegations in the recent past especially in Punjab and the concern over the acquittal of the accused persons from the cases registered for such incidents. He wanted to know that whether the Government has filed appeal against acquittal in any such case or not. (Raised by Senator Aitzaz Ahsan on 7th March, 2017)
- 2. Regarding the reported incidents of abduction of 150 women from Rawalpindi who were reportedly trafficked to Afghanistan for ransom and specifically about the case of one Ms. Farzana whose FIR is not being registered by Police. (Raised by Senator Maulana Hafiz Hamadullah on 7th March, 2017)
