#### **RESOLUTION**

#### Senator Raja Zafar ul Haq, Leader of the House, moved the following resolution:

The Senate of Pakistan, meeting at a time when there is an on-going popular, spontaneous, indigenous and widespread uprising of the oppressed people of Jammu and Kashmir;

*Expresses* its strong solidarity with the Kashmiri people for valiantly resisting the brute repression of the Indian occupation forces and acknowledges that they are writing a glorious chapter in the annals of historical freedom movements, through their determination, will and spirit of sacrifice;

*Strongly Condemns* the India's use of bullets and pellets which are killing, maiming and wounding a whole new generation of unarmed boys and girls, which is a crime against humanity;

*Reiterates* that the only way out is to grant the people of Jammu and Kashmir their inalienable right of self-determination in accordance with the relevant United Nations' Resolutions, to which India and Pakistan are signatory;

*Urges* the international community to immediately take notice of the grave human rights violations in the occupied Jammu and Kashmir to prevent India to desist from war hysteria to distract attention away from India's crimes against humanity in Jammu and Kashmir;

*Urges* the United Nations to hold independent inquiry into the 'Uri incident' to take it to its logical conclusion;

*Resolves* that if the Indian government dares to embark on any military adventure against Pakistan, the people, the Government and the Armed Forces of Pakistan will stand united as one to face and defeat any form of aggression with all the might of their command.
