## **RESOLUTIONS**

**1.** Senator Zeeshan Khanzada moved the following resolution:

"'This House recommends that the Government should make an up-to-date system for disposal of garbage including establishment of sewerage treatment plants in different areas of Islamabad and also arrange for proper disposal of large quantity of poultry waste outside the Islamabad jurisdiction which runs down to Rawal Lake in Islamabad to save the people from dangerous diseases caused by garbage and contaminated water."

# The Resolution was not opposed and unanimously passed by the House.

2. Senator Mushtaq Ahmed to move the following resolution:-

"This Hose recommends that the Government should take necessary steps to fix the minimum wage for labourers at par with the price of one tola gold, ensure the provision of financial assistance and rashon to daily wagers and labourers working in the informal sectors and issue special passes to the labourers for purchasing kitchen items from utility stores on discount rates."

#### The Resolution was deferred on request of the Member.

3. Senator Sirajul Haq moved the following resolution:-

"In pursuance of the resolution of the 40th session of OIC's Foreign Ministers in 2013, the Senate and National Assembly Resolutions of 20th May, 2016 and 29th May, 2018, the House urges upon the Government to: (i) celebrate the 15th day of Ramazan ul Mubarak as Orphan's Day on official and unofficial level;

(ii) launch a campaign on print and electronic media to create awareness in people to play their role in looking after the orphans in society;

(iii) launch schemes for the welfare of orphans at district level, strengthen the institutions working for welfare of orphans and take effective steps for the better brought up and protection of orphans in the country;

(iv) announce special incentives for the local and international NGOs working for the welfare of orphans in the country;

(v) provide scholarships and fee waiver to the intelligent orphan and abandoned children in all public and private sector educational institutions;

(vi) ensure the provision of necessary funds on monthly basis for fulfilling the needs of food, health and shelter of the orphan and abandoned children."

# The Resolution was not opposed and unanimously passed by the House.

4. Senator Zeeshan Khanzada moved the following resolution:-

"This House recommends that the Government should introduce uniform pay scales for all the Government employees with particular reference to those working in BPS-1 to 16 in Federal Government Departments."

#### The Resolution was opposed by the Minister of State for Parliamentary Affairs thereafter, the Chairman directed to the member to redraft the Resolution.

**5.** Senator Kauda Babar on his behalf and behalf of Senator Naseebullah Bazai moved the following resolution:-

"This House recommends that the Government should take immediate steps to appoint ambassadors of Pakistan against the 20% quota reserved for non-career diplomats.

The House also recommends that the said quota should be equally distributed amongst the provinces and preference should be given to those areas which have had lower representation/share in the ambassadorial posts, especially Balochistan, rural Sindh, Khyber Pakhtunkhwa and Punjab."

The Resolution was not opposed and unanimously passed by the House.

**6.** Senator Kauda Babar on his behalf and behalf of Senator Naseebullah Bazai moved the following resolution:-

"The Senate of Pakistan:

Acknowledging the fact that the province of Balochistan has been endowed with vast uninhibited land that offers huge potential for production of solar and wind energy;

Showing dismay that these potentials have so far remained untapped due to overly bureaucratic procedures and lack of focus on the province. Moreover, undue delay and hindrances in approving the solar energy projects from the already allocated 3000 MW for the province, with many projects pending for approval for the last two to three years;

Expressing deep concern on the fact that the Government is not allowing the establishment of solar projects in the province of Balochistan with a rate of even Rs.7 – 8, whereas similar projects in other provinces / areas have been approved at the rate of 14 cents;

the Senate of Pakistan, therefore, demands that:

(1) the Federal Government should take immediate steps for approval and facilitation of solar and wind energy projects in Balochistan on priority basis in order to better utilize the uninhibited vast land of the province which will not only create employment opportunities for the youth of the province but will also improve the economic conditions of the province as well as of the country, generate tax and non-tax revenue and greatly improve energy mix situation for environment friendly, sustainable and low cost energy.

(2) urge the Government to direct the Power Division, NTDC and CPPA to immediately approve projects of solar and wind energy in the province of Balochistan from the 3000 MW allocation, and ensure facilitation of more such projects through one-window operation by eliminating excessive documentation and procedures that severely discourage the investors and cause undue delays in setting up of such important projects in the province.

(3) call upon NEPRA to approve tariffs for solar energy projects of Balochistan at parity with similar projects in other provinces, on urgent basis."

## The Resolution was not opposed and unanimously passed by the House.

**7.** Senator Kauda Babar on his behalf and behalf of Senator Naseebullah Bazai moved the following resolution:-

"The Senate of Pakistan, being the House of Federation, taking note that,-

- officers belonging to such occupational groups/services which have direct nexus with the provinces , including but no limiting to Pakistan Administrative Service, Police Service of Pakistan, In-land Revenue Service, do not perform duties in the provinces during their entire term of service and yet manage to get promotions without having the experience of horizontal mobility which ensure wide experience and exposure and place; and

- remain posted on the same post, in the same province, same city, same status over three years in volition of instructions with regard to "Normal Tenure of Posting" and "Posting on Deputation "as provided in the ESTACODE, Recommends that,-

(i) officers belonging to such occupational groups/services which have direct nexus with the provinces , including but no limiting to Pakistan Administrative Service, Police Service of Pakistan, In-land Revenue Service, should not be granted promotions in the next grades till such time they have experience of serving in a province for a period of at least three years;

(ii) Officers of all occupational groups who have completed normal tenure of three years at same post and still working shall be transferred forthwith to implement the provision of ESTACODE in letter and spirit; and

(iii) Officers/Officials working on deputation for last three years shall be repatriated to their parent departments' forthwith."

# The Resolution was not opposed and unanimously passed by the House.

**8.** Senator Sajjad Hussain Turi on his behalf and behalf of Senators Dilawar Khan and Zeeshan Khanzada moved the following resolution:-

"This House demands that the Government should allow prohibited bore (PB) arms licences to all Parliamentarians – Senators, MNAs, MPAs of all four provinces and BS-20 and above officers of the Federal and Provincial governments."

# The Resolution was not opposed and unanimously passed by the House.

## **POINT OF PUBLIC IMPORTANCE**

- Senator Mian Raza Rabbani raised question in connection with the failure of present Government to restructure the loss making enterprises like Pakistan Still Mill.
- Senator Mohsin Aziz spoke about Pakistan Still Mills.
- Senators Muhammad Usman Khan Kakar a spoke about Job Quota of Baluchistan which has been merged in Aghaz Haqooq e Baluchistan. Referred to Implementation Committee. He also spoke about Locust Attack in Baluchistan Referred to Standing Committee on National Food Security.
- Senator Javed Abbasi spoke about Adjournment motion which needs to be fixed. He also spoke about stranded Pakistanis in Gulf countries who are in great problems. Chairman directed to Secretariat to seek reports from Foreign office, Overseas Pakistanis Foundation and Aviation Division.
- Senator Sherry Rehman spoke about stranded Pakistanis who are not being taken care of by Government.
- Senator Hilal Ur Rehman spoke about Pandemic and the failure of Government to deal with problems of overseas Pakistani expensive air tickets are being offered from Gulf countries. Embassies are not looking after overseas Pakistanis.
- Senator Musadik Masood Malik spoke about Pandemic and increasing number of cases in country failure of Government. He also spoke about display of false map of Kashmir by PTV in which Azad Jammu Kashmir showing as part of India. Referred to Standing Committee on Information Technology and Telecommunications.
- Senator Sirajul Haq spoke about Stranded Pakistanis Students and workers. Expensive air tickets are being provided. No take care of overseas Pakistanis is being made.
- Senator Dr. Jehanzeb Jamaldini spoke about Corona virus and Locust.
- Senator Sassui Plijo spoke about Corona Virus and non-serious approach of Government to deal with pandemic.
- Senator Kauda Baber spoke about two sad incidents in Baluchistan one in Turbot and second in Hazara Town. He also spoke about less release of funds allocated for PSDP in Baluchistan.
