Senator Mian Muhammad Ateeq Shaikh, on behalf of Senator Farooq Hamid Naek, Chairman, Standing Committee on Finance, Revenue and Economic Affairs, presented report of the Standing Committee on the Money Bill further to amend the Members of Parliament (Salaries and Allowances) Act, 1974 [The Members of Parliament (Salaries and Allowances) (Amendment) Bill, 2020].

# MOTION [Under Rule 130 (8)]

Senator Mian Muhammad Ateeq Shaikh, on behalf of Senator Farooq Hamid Naek, Chairman, Standing Committee on Finance, Revenue and Economic Affairs, moved that the recommendations on the Money Bill further to amend the Members of Parliament (Salaries and Allowances) Act, 1974 [The Members of Parliament (Salaries and Allowances) (Amendment) Bill, 2020], as reported by the Standing Committee, be considered and adopted.
