ACKNOWLEDGEMENT OF PRESENCE

Chairman acknowledged the presence of former Senator Mr. Sanaullah Baloch who was present in the gallery to witness the proceedings of the House.

LEGISLATIVE BUSINESS

1. Senator Karim Ahmed Khawaja moved that the Bill further to amend the Pakistan Baitul-Mal Act, 1991 [The Pakistan Bait-ul-Mal (Amendment) Bill, 2017], as reported by the Standing Committee, be taken into consideration, at once.

The Motion was put to the House which was adopted.

Thereafter, the House started second reading of the Bill i.e. clause by clause consideration.

After second reading of the Bill, Senator Karim Ahmed Khawaja moved that the Bill further to amend the Pakistan Bait-ul-Mal Act, 1991 [The Pakistan Bait-ul-Mal (Amendment) Bill, 2017] be passed.

The Motion was put to the House and the Bill was passed unanimously.

2. Senator Karim Ahmed Khawaja moved that the Bill further to amend the Pakistan Penal Code, 1860 and the Code of Criminal Procedure, 1898 [The Criminal Laws (Amendment) Bill, 2017], as reported by the Standing Committee, be taken into consideration, at once.

Before putting the Motion top the House, the Minister for Law and Justice drew attention of the Chair towards the objective of the Bill which prima facie seems against the injunctions of Islam, therefore, he requested the Chair to refer the Bill to the Council of Islamic Ideology for opinion.

After discussion, the Chairman deferred the Bill till next Private Members' Day and directed the Secretariat to provide him the minutes of the meetings of the Committee wherein the Bill has been discussed in order to ascertain the exact position of the Bill.

MOTION [Under Rule 126(7)]

Senator Mohammad Azam Khan Swati, moved that the Bill further to amend the Pakistan Penal Code, 1860 [The Pakistan Penal Code (Amendment) Bill, 2017] (Amendment of section 323), as passed by the Senate and transmitted to the National Assembly but not passed by the National Assembly within ninety days of its laying in the National Assembly, be considered in a joint sitting.

The Motion was put to the House and adopted.

BILLS TO BE WITHDRAWN

[Under Rule 115]

Senator Mohammad Azam Khan Swati sought leave of the House to withdraw the following Bills: -

- (i) The Pakistan Penal Code (Amendment) Bill, 2017 (Amendment of sections 273, 274, 275); and
- (ii) The Pakistan Penal Code (Amendment) Bill, 2016 (Insertion of sections 320A and 337JJ).

The Motion was put to the House and leave to withdraw the Bills was granted by the House.

Thereafter, Senator Mohammad Azam Khan Swati withdrew the abovementioned Bills.

WALKOUT BY THE MEDIA GALLERY

The Media representatives in the media gallery staged walkout of the proceedings.

The Chairman asked Senators Mushahid Ullah Khan and Taj Haider to speak with the media persons about their grievances.

Senator Mushahid Ullah Khan after having discussion with media persons informed the House that the media gallery has walked out as protest against the attack on Mr. Ahmed Norani a journalists in Islamabad and they have demanded that the House in order to show solidarity must suspend the proceedings for some time.

The Chairman Senate condemned the attack on the journalist and acknowledged the sacrifices and importance of media in the restoration of democracy.

The Chairman also directed the Government to Table the draft Bill for the protection of Journalists in either House for its enactment within a period of one month.

Thereafter, with the sense of the House, the Chairman suspended the proceedings for five minutes and the House reassembled at 4:450 p.m.

"This House recommends that the Federal Government should establish separate university for women in every district of the country."

5. The following resolution in the name of Senator Maulana Hafiz Hamadullah was dropped due to his absence:-

"This House recommends that the Government should conduct an inquiry into the matters pertaining to the release of Raymond Davis, a U.S national, who was involved in a case of double murder, in the light of disclosures made by the Minister for Foreign Affairs in his statement on a calling attention notice which was taken up in the House on 25th August, 2017 and present the report thereof to the House."

6. The following resolution in the name of Senator Chaudhary Tanvir Khan was dropped due to his absence:-

"The House recommends that the Government should launch a Special housing scheme for low income people in Islamabad."

"This House recommends that necessary amendments may be made in the relevant laws to make provision of stringent punishment for those manufacturing spurious and sub-standard drugs in the country."

The Resolution was put to the House which was passed unanimously.

MINISTERIAL RESPONSE ON THE POINTS OF PUBLIC IMPORTANCE

i) Regarding the use of narcotics in the educational institutions of Balochistan, raised by Senator Dr. Jehanzeb Jamaldini on 20th September, 2017.
