- 2. The Committee had detailed discussion on the matter. The Mover of the agenda Senator Muhammad Usman Khan Kakar explained that PTV Bolan represents regional culture of Balochistan and signifies an integral federal unit. He said that there are complaints that it is being closed down which, he added, should not be closed as it is a major source of entertainment for the locals.
- 3. The Managing Director PTVC informed the Committee that PTV Bolan is telecasting its programmes and transmission seven days a week in regional languages such as Brahvi, Balochi and Pashto, and airs programmes on entertainment, current affairs and news. He assured the Committee that there is no such plan for its closure.

4. The Committee with the consent of the Mover disposed of the matter for onward report to the House.
