FATEHA

The House offered Fateha for the following:-

- i. Molana Dr. Adil Khan murdered in Karachi.
- ii. Armed forces personnel martyred in Waziristan, Balochistan, LoC and Pak-Afghan border.
- iii. Mr. Rashid Rabbani, former Senator and Special Assistant to Chief Minister Sindh.
- iv. Fateha was also offered for the departed soul of first Prime Minister of Pakistan Sardar Liaquat Ali Khan on the eve of his death anniversary i.e. 16th October, 1951.

After offering of Fateha, Leader of the Opposition stated that keeping in view the recent wave of terrorism in the country in which law enforcement agencies are being specifically targeted and the situation of LoC and Western Border, the Minister for Defence may be asked to come in the House and made statement on the latest situation.

Adviser to the Prime Minister on Parliamentary Affairs endorsed the suggestion and assured that the Minister for Defence will be asked to come in the House to apprise the House in this regard.

The Adviser further spoke about the Indian narrative of maligning the armed forces of Pakistan which is an attempt to divert the attention of world community from sheer violations of Human Rights in India and in IOK.

Senator Atta Ur Rehman demanded a detailed report on the incident of assassination of Molana Adil in Karachi. Chairman directed to seek report of the incident.

CONDOLENCE RESOLUTIONS
