- During the course of briefings, the Committee deliberated upon the matter in detail and sought views of the Mover, the Federal Secretary, Information and Broadcasting Division, and the Managing Director PTVC. The summary of the proceedings of the meetings on the subject matter is provided below.
- 6. The Mover Senator Abdul Rehman Malik maintained that he has observed with great concern that PTV despite a state run TV does not provide equal representation to political parties of opposition benches on its current affairs programmes. He added that it is a democratic right of opposition parties to appear on state run TV and present their views on political and policy matters. He demanded that record of representation of political parties in current affairs talk shows broadcasted in the month of August, 2020 on PTV may be provided to the Mover.
- 7. The Secretary, Information and Broadcasting Division, informed the Committee that it is the policy of the government to ensure representation of political parties on PTV programmes. The Managing Director PTVC briefed that all political parties and their representatives are regularly invited to talk shows on PTV based on the topics/themes and opposition's ratio of participation in such talk shows is double as compared to that of government.
- 8. The Committee on the request of the Mover directed that record of representation of political parties in current affairs talk shows broadcasted in the month of August 2020 on PTV may be provided to the Mover.

9. The Committee with the consent of the Mover disposed of the matter for onward report to the House.
