RESOLUTIONS

In order to improve the financial conditions of labours, the House demands that the Government should ensure timely allocation and disbursement of financial grants on deaths, marriages and children educational stipends to labourers/workers from Workers Welfare Fund alongwith hundred percent increase in workers' pension."

The House also condemns Indian violation of the international norms of staff behaviour, International Law and United Nations. The House urges upon the Government to take up the incident of unprovoked firing by the Indian Forces on the UNMOGIP vehicle on all international diplomatic fora including the United Nations."

49. SENATOR BAHRAMAND KHAN TANGI to move the following resolution:-

"This House strongly condemns the incidents of domestic violence and demands that the Government should establish special desks in every police station in Islamabad Capital Territory to help the victims of domestic violence."

50. SENATOR SEEMEE EZDI to move the following resolution:-

"The House is cognizant of the fact that in order to strengthen democracy and democratic principles in the country, there is dire need to make the people in Pakistan aware of their civic rights and duties as enshrined in Articles 9 to 28 of the Constitution of Pakistan.

The House recommends that in order to make the people of Pakistan in general and the residents of Federal Capital in particular aware about their civic rights and duties as vigilant citizens of Pakistan, the Federal Government should make arrangements for compulsory teaching of civic education encompassing the subjects of public good, environment protection, public safety, basic health care and obeying traffic rules and regulations in the national curriculum being taught at primary and secondary levels in the educational institutions under the administrative control of the Federal Government."
