Senator Dr. Shahzad Waseem, Leader of the House on his behalf and behalf of Senator Syed Yousuf Raza Gillani, Leader of the Opposition, moved the following motion under Rule 218 of the Rules of Procedure and Conduct of Business in the Senate, 2012:-

"That the Senate may discuss Israel's systematic assault against Palestinian worshippers in the Haram-al-Sharif (Masjid Al-Aqsa) and Gaza during the holy month of Ramadan and Israeli apartheid state's terrorism and mass murder in Palestine, as well as the ongoing violent and illegal occupation of Palestinian lands in the world's worst example of settler colonialism."

Chairman announced that Parliamentary Leaders may speak for 5-7 minutes whereas the Members may speak for 5 minutes.
