these incentives are only given the autonomous institutions and PIMS is the only institution



which fall in this category. Other hospitals do not fall in that criteria so no incentive is given there. The Chairman inquired whether the incentives are given to staff or only doctors and whether it was taxed. It was informed that the incentives were given to all the staff members but from 2019 it has been discontinued by the Ministry of Finance. It was further said that the incentives may be continued if the Ministry of Finance allow so. The agenda was disposed of.
