SUBJECT: REPORT OF THE SENATE STANDING COMMITTEE ON INTERIOR ON THE POINT OF PUBLIC IMPORTANCE REGARDING NADRA OFFICES IN UPPER AND LOWER DIR

I, Senator Mohsin Aziz, Chairman Senate Standing Committee on Interior, have the honor to present report of the Committee on the point of public importance regarding NADRA offices in Upper and Lower Dir. The matter was raised by Senator Mushtaq Ahmed Khan in the Senate in the Senate sitting held on 12th November, 2021 whereupon, the issue was referred to the SSC on Interior for consideration and report.

3. The Committee considered the Bill in its meeting held on 28th April, 2022. The meeting was attended by the following:-

- 4. The senior officers of the Ministry of Interior and NADRA were also present in the meeting.
- 5. The Mover briefed the issue. Chief Operating Officer, NADRA informed the Committee that renovation work of new spacious buildings of NRC Wari and NRC Female Wari are under progress. Moreover, building of NRC Tehsil Brawal has also been hired and under renovation. Hiring of building to establish NADRA office at Tehsil Munda is also under process which will be made operational after completion of codal formalities.
- 6. Chief Operating Officer (COO), NADRA further informed that posting of minimum one female staff is mandatory in every NRC. He further informed that two mobile vans are working in Lower Dir and one mobile van is working in Upper Dir.
- 7. The Committee appreciated the efforts made by NADRA to address the genuine concerns of the Mover. The Mover also expressed his satisfaction.
- 8. The Committee disposed of the matter with the following recommendations:-
 - One mobile van may be increased for Upper Dir.
 - Posting of female staff in all NADRA offices may be ensured.

The Committee also gave approval of presentation of report of the Committee to the House.
