The following Act of Majlis-e-Shoora (Parliament) received the assent of the President on the 5th April, 1993 and is hereby published for general information:—

#### ACT No. IX of 1993

An Act further to amend the West Pakistan Minimum Wages for Unskilled Workers Ordinance, 1969

WHEREAS it is expedient further to amend the West Pakistan Minimum Wages for Unskilled Workers Ordinance, 1969 (W.P. Ordinance XX of 1969), for the purposes hereinafter appearing;

It is hereby enacted as follows:

- Short title, extent and commencement.—(1) This Act may be called the West Pakistan Minimum Wages for Unskilled Workers (Amendment) Act, 1993.
  - (2) It extends to the whole of Pakistan.
- (3) It shall come into force at once and shall be deemed to have taken effect from the first day of July, 1992.

- 2. Amendment of section 2, Ordinance XX of 1969.—In the West Pakistan Minimum Wages for Unskilled Workers Ordinance, 1969 (Ordinance XX of 1969), bereinafter referred to as the said Ordinance in section 2, in clause (g), after the words "conveyance allowance" the commas and words ", cost of living allowance, special allowances" shall be inserted.
- Amendment of section 3, Ordinance XX of 1969.—In the said Ordinance, in section 3, for the explanation the following shall be substituted, namely:—

Explanation.-In this section,-

- (i) "month" means a normal working period of twenty-six days calculated at the rate of forty-eight hours of work per week; and
- (ii) "wages" include cost of living allowance as admissible under the Employees' Cost of living (Relief) Act, 1973 (I of 1974), dearness allowance and special allowances announced by the Government, from time to time, before the commencement of the West Pakistan Minimum Wages for Unskilled Workers (Amendment) Act, 1993.
- Substitution of Schedule, W.P. Ordinance XX of 1969.—In the said Ordinance, for the Schedule the following shall be substituted, namely:—
