2. The Mover briefed the Committee about his concerns and complaint against the Acting Governor State Bank of Pakistan. He was of the view that the members of the Parliament calls the Government functionaries about the public issues but every time he and some other members of the Senate and National Assembly called the Acting Governor SBP, he never responded and never called back which amounts to obstruction the parliamentary duties of the Members.

- The Acting Governor State Bank of Pakistan who was present in the meeting in person at 3. the very outset extended unconditional apology and stated that if any inconvenience has caused to the Members he felt sorry for that. He was of the view that keeping in view the hectic engagements regarding financial matters in recent past he could not respond the calls made on his cell number, however, he assured that a call log is prepared of the calls made in his office number and he always responds back to important calls made in his office. However, he once again extended his apology and assured that he will remain careful in future.
- The Mover and the other Members of the Committee expressed their satisfaction on the reply of the Acting Governor and accepted the apology tendered by him. The Committee unanimously recommended that the Mover may withdraw his Privilege Motion in view of the apology tendered by the Acting Governor SBP. The Mover acceded to the recommendation of the Committee and withdrew his Privilege Motion.

In view of the above recommendation, the Committee also gave approval for presentation of report to the House. Hence, this report is presented to the House.
