3. The Committee took up discussion on the issue in its meetings held on 26-08-21, 04-11-21, 21-02-22, 16-09-22 and 05-01-23. The following members of the Committee attended the meeting held on 5<sup>th</sup> January, 2023:

4. The Ministry of Overseas Pakistanis and Human Resource Development briefed the Committee regarding the Point of Public Importance raised by Senator Mushtaq Ahmed. The Mover, however was dissatisfied with the response submitted by the Ministry in this regard. He apprised the Committee that oversees Pakistanis had been instrumental drivers of the economy during the Covid pandemic through their remittances. However, in time of need, the

Government of Pakistan did not support them as it should have. Flights from Peshawar were suspended, and ticket prices were raised by the PIA. Overseas Pakistanis had to travel abroad via Kabul, but the Government failed to facilitate them there. Even though many overseas Pakistani's had already booked their tickets from Kabul, the Torkhum border was shut down, adding to their problems. He also stated that no assistance in dead body transfer for overseas Pakistanis was provided, and this was also done by private organizations. He inquired about the details of the Community Welfare Fund, including expenditure on overseas Pakistanis. A detailed report was sought from the Ministry in this regard.

5. Following detailed discussions, the Committee disposed the matter, and decided to seek regular updates from the Ministry regarding its activities pertaining to the facilitation of Overseas Pakistanis.
