3. The Committee considered the matter in its meetings held on 20th January, 8th June, 28th July and 25th August, 29th September and held conclusive in its meeting held on 10th October under the Chairmanship of Senator Hidayat Ullah, with the following in attendance:

The Committee took up the matter regarding personal staff posted with the current Director General, Civil Aviation Authority, their grade wise details and mode of appointment. The Committee was apprised that One (1) PSO to DG CAA, one (1) G-II Supervisor, six (6) G-I supervisors, one (1) Head Staff, two (2) Staff, two (2) qasids and two (2) drivers are posted at Director General Secretariat HQCAA Karachi. Moreover 8212 employees are associated with Pakistan Civil Aviation Authority among which 107 resources were appointed during July 1st, 2020 till date. Moreover, a PA to DG CAA, one (1) Assistant Grade-II (HR), one (1) Head Staff, One (1) G.S.A and one Qasid is posted at DG CAA Camp office Islamabad. In addition Senator Behramand Khan Tangi, asked about official vehicles provided to DG CAA, their limit of fuel and nature of private use. Director General, Civil Aviation Authority informed the Committee that authorization of the official vehicles for DG CAA was approved by the Board before his appointment as DG CAA. Regarding the number of official vehicles, it was apprised that only two cars, one for official use and the other for private or family use has been provided. Besides this, Pool cars are also used for the purpose of travelling to other cities like Islamabad or Lahore.

5. The Standing Committee disposed-off the matter and directed that in future the personal staff posted with the DG CAA should be appointed strictly in accordance with his entitlement.
