### **RESOLUTIONS**

1. Senator Sania Nishtar, on behalf of Senators Dr. Shahzad Waseem, Leader Of The Opposition, Sania Nishtar, Kamil Ali Agha, Samina Mumtaz Zehri, Seemee Ezdi, Faisal Saleem Rehman, Mohammad Humayun Mohmand, Mohsin Aziz, Faisal Javed, Fida Muhammad, Prof. Dr. Mehr Taj Roghani, Dost Muhammad Khan, Liaqat Khan Tarakai, Walid Iqbal, Zeeshan Khan Zada, Dr. Zarqa Suharwardy Taimur, Falak Naz, Gurdeep Singh, Fawzia Arshad, Aon Abbas, Ejaz Ahmad Chaudhary, Syed Ali Zafar And Saifullah Abro, moved the following resolution:-

"The Senate of Pakistan recalls Article 37(a) of the Constitution of the Islamic Republic of Pakistan which stipulates that the State shall promote, with special care, the educational and economic interests of backward classes or areas.

The Senate of Pakistan further recalls Article 38(a) of the Constitution of the Islamic Republic of Pakistan which stipulates that the State shall secure the well-being of people, irrespective of sex, cast, creed, or race by raising their standard of living.

The House recognizes that Pakistan currently faces unprecedented food inflation, which is crippling for working class families, who are struggling to maintain their current standard of living and require government support.

The House further recognizes that the Ehsaas Rashan Riayat program was end-to-end digitized, and helped create a digital ecosystem, connecting 15,000 merchants through a Mobile Point of Sale/Point of Sale, National Bank of Pakistan as core service provider, BISP as the repository of socioeconomic data and Ministry of Poverty Alleviation and Social Safety as the primary program owner.

This House demands that the Federal Government, through the Ministry of Poverty Alleviation and Social Safety, re-start the Federal Ehsaas Rashan Riayat Program.

The House also demands that the Federal Government aim to collaborate with the governments of each province and federating units to devise a cost-sharing mechanism, whereby both the Provincial and Federal Governments each contribute funds to the program.

"The House firmly believes that political stability is immanent for economic stability. This House is of the opinion that, according to the spirit of Article 218, the general elections to all the assemblies must be held simultaneously on time under neutral caretaker set ups under Article 224 with a view to bring true political and economic stability to the country.

Holding separate elections in Punjab, the largest federating unit having more than 50 per cent National Assembly seats, will inevitably influence the outcome of the general elections to the National Assembly seat in Punjab. As such it will trample upon the smaller provinces role in the Federation.

This House therefore resolves that General Elections to the National Assembly and all Provincial Assemblies be held together for strengthening the Federation."
