1. Senator Shahadat Awan, Minister of State for Law, moved under Rule 263 of the Rules of Procedure and Conduct of Business in the Senate 2012 that the requirement of the Rule 25, 29, 30 and 133 of the said rules be dispensed with in order to enable the House to discuss and pass the Resolution regarding incident of the violence in various parts of the country on 9th May, 2023.

The Motion was put to the House and adopted.

RESOLUTIONS

1. Senator Shahadat Awan, Minister of State for Law, on behalf of Senators Muhammad Ishaq Dar, the Leader of the House and Senator Azam Nazeer Tarar, Yousuf Raza Gilani, , Beharamand Khan Tangi, Nisar Ahmad Khoro, Palwasha Muhammad Zai, Asif Saeed Kirmani, Krishna Kumari Devi, Waqar Mehdi and Anwar Lal Dean , moved the following resolution:-

"The House is Appreciative and cognizant of the great sacrifices the martyrs have rendered for peace, safety, security and the stability of Pakistan and the unmatched role our Armed Forces have played in safeguarding the motherland from all external and internal threats;
