Mr. Miftah Ismail (Minister for Finance and Revenue): I, lay before the Senate a copy of Finance Bill, 2022, containing the Annual Budget Statement, as required under Article 73 of the Constitution of the Islamic Republic of Pakistan.

# Motion under Rule 130 moved by Mr. Miftah Ismail Minister for Finance and Revenue for making recommendations to the National Assembly on The Finance Bill, 2022-23 containing Annual Budget Statement, as required under Article 73 of the Constitution

Mr. Miftah Ismail: I move that Senate may make recommendations if any, to the National Assembly on the Finance Bill, 2022, containing the Annual Budget Statement, as required under Article 73 of the Constitution of the Islamic Republic of Pakistan.

Mr. Chairman: The notices for the proposals to make recommendations on the Finance Bill, 2022, containing the Annual Budget Statement, may be submitted by the Members to the Senate Secretariat by Monday the 13<sup>th</sup> June, 2022 at the latest by 12 noon. No proposal will be entertained after that date. These recommendations should be with reference to the Finance Bill, 2022, containing the Annual Budget Statement. Recommendation having no relevance to the Finance Bill, containing the Annual Budget Statement is outside the purview of the Article 73 and hence not admissible. Furthermore, a Member shall not give notice of a proposal for making recommendations to the Annual Budget Statement which relates to the expenditure charged upon the Financial Consolidated Fund under Clause (1) of Article 82 of the Constitution. The proposals received for making recommendations on the Finance Bill, shall be sent to the Senate Standing Committee on Finance, whereas the recommendations pertaining to the PSDP shall be sent to the Senate Standing Committee on Planning, Development and Special Initiatives. The Senate Standing Committee on Planning, Development shall examine and Special Initiatives the recommendations pertaining to PSDP and forward the same to the Senate Standing Committee on Finance within 07 days which will after incorporating the recommendations of the Senate Standing Committee on Planning, Development and Special Initiatives in its own recommendations, present its report before the House within a period of 10 days. In the meantime, the Senate would discuss the Finance Bill, 2022, containing the Annual Budget Statement, from Monday the 13<sup>th</sup> June, 2022.

The Parliamentary Party Leaders are requested to provide names of the speakers of their respective parties. The Senate would finally consider the report of the Standing Committee on Finance and make recommendations to the National Assembly.
