**Makhdoom Shahabuddin:** During the last five years, the Ministry of Health has not received aid from any foreign donor for prevention and control of Hepatitis and Cancer in the country. For control of Malaria, the Directorate of Malaria Control has received financial assistant only from Global Fund for AIDS, TB and Malaria (GFATM) as per following details:

- (b) The Government is taking a number of steps to increase gainful employment opportunities and balance the distribution of doctors between urban and rural areas of Pakistan. Some key initiatives are:
  - (i) Development and planning of a Human Resource for Health strategy (HRH strategy) to growing challenges of staff retention, recruitment, distribution, attrition, career development, and satisfying work environment.
  - (ii) The new Health Policy envisages that development of the Essential Health Services Package will lead to more efficient, effective and integrated delivery of health services and human resource management including creating enhanced employment opportunities for doctors.
  - (iii) The Health Policy also envisions a greater role of public-private partnerships in increasing employment opportunities and balanced redistribution of doctors in areas of greatest need; and
  - (iv) Shifting towards a more proactive and expedited recruitment process for hiring of doctors for primary and secondary level health facilities will also increase employment opportunities and reduce the number of unemployed doctors in the country.

"The Federal Government may utilize the Fund for conducting research, development or evaluation of a drug either itself or through a research institution working under its control or disburse it among investigators or institutions for such purposes subject to such conditions as may be specified and for that matter, it may also utilize the fund to upgrade and establish Drugs Research and testing laboratories and a unit in the Drugs Control Section, Ministry of Health, for evaluation and monitoring of the research proposals and projects and management of the fund"

- **Ch. Ahmad Mukhtar:** (a) The names, booking and confirmation date of passengers who traveled in business class of PIA flight PK-786 from Heathrow Airport (London) to Islamabad on the night of 22nd November, 2009 are provided as Annexure-A.

- **Ch. Ahmad Mukhtar:** (a) & (c) The Federal Government is currently evaluating various proposals for financial and organizational restructuring of PIA; however, final decision has not so far been taken.
- (b) PIA management has taken some initiatives to achieve its cost cutting objectives and to make PIA a profit earning organization, which are given below:—

# **Marketing Initiatives**

- Shifting to saber GDS to reduce expenses.
- Carrying passengers on domestic leg of International flights to generate additional revenue.

- Achieved zero percent Agents' commission.
- Additional revenue through fares optimization.
- Appointment of new GSAs to reduce the administrative cost and widen selling base.
- Free transportation service between Toronto and Montreal/Ottawa to cater for additional Canadian market.

#### Pakistan Remittance incentive (PRI)

Pakistan Remittance Initiative (PRI), a joint venture between the Ministry of Finance, State Bank of Pakistan and the Ministry of Overseas Pakistanis has entered into an alliance with PIA. This aims to achieve an increase in PIA's share in the travel by expatriate Pakistanis.

# **Operational Measures**

- Retrieval of grounded Boeing 747-300 fleet to utilize on Saudi Arabia routes to cater for Hajj/Umrah flights and additional capacity demand.
- Reconfiguration of 747-300 fleet by enhancing the seating capacity which resulted in higher revenue generation.

## **Network Development**

PIA is constantly on the lookout of exploring new avenues and network development. Several new routes have been introduced and frequencies on existing routes have been enhanced as under:—

- Non-stop flights from New York to Pakistan have been introduced, reducing travel time for incoming passengers and cost savings.
- Three weekly services from Islamabad to Leeds/Bradforts.
- Islamabad and Lahore air-linked with Nawabshah and Hyderabad.
- Two weekly services introduced between Islamabad/Peshawar and D.I. Khan.
- Restoration of flights to Zhob for the people of remote areas of Balochistan.
- Frequency between Karachi and Sialkot increased to three per week.
- Two weekly flights for Istanbul extended to Amsterdam.
- Weekly two flights started each to Barcelona and Frankfort.
- New flights introduced on Islamabad-Kathmandu, Peshawar-Kabul, D.G. Khan-Dubai, Sialkot-Abu Dhabi, Sialkot-Bahrain and Sailkot-Kuwait routes.

## **Engineering and Maintenance**

- PIA Engineering, certified by Turkish, Sri Lankan and Jordan Civil Aviation Authorities, providing third party business.
- Automatic test equipment facility for A310 has been acquired.
- Test and repair facility for approximately 50 components has been developed with savings of US\$0.5 M through local fabrication.
- In-house repair and testing facility of CF6-80 Engine has been developed, which has resulted in substantial savings in engine maintenance cost of A310.
- State of the art test facility acquired for PW127 engines installed on ATR42-500 aircraft. This up gradation of PIA Engine Test Facilities will concern PIA's ability to fully overhaul PW127 engines which will result in huge saving annually.

The management initiated the organizational re-structuring process in order to increase productivity and employee moral.

### **E-Solutions**

- PIA concluded 44 interline E-ticketing agreements with other airlines, which will facilitate passengers traveling to/from non-PIA destinations.
- Web Ticketing has been expanded and now it covers all Domestic Routes, USA, Canada, UK, Gulf stations, Dubai, Jeddah, Oslo, Muscat, Hong Kong, Copenhagen, Frankfurt, Barcelona and Paris with recent addition to Milan, Doha and Kuwait.

On its part, the MLG&RD has coordinated implementation of Tameer-e-Pakistan Programme / Khushal Pakistan Programme-I during 2002-2008 and is coordinating People's Works Programme-I w.e.f. 1st July, 2009. Under these programmes, Rs. 14428 million were released under TPP/KPP-I and Rs.5248 million under PWP-I, for execution of schemes as identified by the parliamentarians all over the country.

- (c) As stated above, Rural Development is a Multi-dimensional and Multi-tiered activity. It can not be circumscribed in terms of specific programmes/schemers.

As per instruction, students belonging to affected areas were allowed free education in the institutions besides the provision of books free of cost.
