- (b) *whether there is any proposal under consideration of the Government to give special package to the people of Bahawalpur Division under the said programme?*

Minister Incharge of the Cabinet Division: (a) Following numbers of beneficiaries have been enrolled in the two Divisions.

@@123. ***Begum Najma Hameed:** (Notice received on 07-09-2009 at 09:00 a.m.)

Will the Minister for Finance and Revenue be pleased to state:

- (a) *the percentage of price-hike registered in the country during the last two years; and*
- (b) *the steps being taken by the government to control the price-hike?*

Ms. Hina Rabbani Khar: (a) Price hike commonly known as inflation which is usually measured by the changes in consumer price index (CPI) has been registered at 12.0 percent in 2007-08, 20.8 percent in 2008-09. CPI declined to 10.7 percent in August 2009.

(b) 1. On a regular basis, the government reviews the price situation in the country in every Economic Coordination Committee (ECC) meeting and discusses the movement of price of these essential items and takes necessary steps of maintaining stability in prices.

2. To ensure competition and fair play in the market, the Monopoly Control Authority (MCA) has been converted into Competition Commission of Pakistan (CCP) by granting it powers to prevent non-competitive behaviour in the market.

Food items carry heavy weight in the consumer basket and has direct impact on the well being of common man. The government has taken following measures to control price hike of edible items in the country:

- (a) In view of a possible delay in cane crushing, the ECC allowed the import of 100,000 tons of sugar to build TCP stocks.
 - (b) In order to stabilize the prices of essential items in the country, the government is providing various essential items at Utility Stores Corporation at cheaper rate than the open market. The government also provides sugar at subsidized rate of Rs. 38/Kg to the consumer through Utility Stores Corporation.
 - (c) All Provincial Governments are responsible for price check/ control and take appropriate measures to check overcharging.

Makhdoom Amin Fahim: US\$ 14-2 million foreign exchange was earned by exporting 6022 MT of tobacco during the year 2008-09.

Ms. Hina Rabbani Khar: (a) An amount of US \$ 2,979.64 million was received from international donors for development schemes/projects during the last three years.

(b) Funds utilized for development scheme /projects exclusively meant for Punjab amounted to \$ 320.57 million. Details are at Annex-I.

(c) No specific scheme/project was launched exclusively for Bhawalpur, Rehim Yar Khan and Bahawalnagar districts during the last three years.

Ms. Hina Rabbani Khar: (a) Requisite information in respect of officers from BPS-16 and above is at Annex-A.

141. ***Mir Hasil Khan Bizenjo:** (Notice received on 03-08-2009 at 14:30 p.m.)

Will the Minister for Finance and Revenue be pleased to state:

- (a) *whether there is any proposal under consideration to the Government to introduce two groups of services, viz "Pakistan Revenue Service" and "Inland Revenue Service" in FBR, if so, the time by which these new groups will become functional;*
- (b) *the names of existing service groups in FBR which will be made part of each of the said groups;*
- (c) *whether any option will be given to the officers/officials of the said department to join either of those groups;*

- (d) *the procedure to be adopted for maintaining the seniority lists of the officers of the said groups; and*
- (e) *the name of authority which will give promotion to the officers/ officials of each of those groups?*

Ms. Hina Rabbani Khar: (a) Yes. Federal Government has created a new Occupational Service namely “Inland Revenue Service” with immediate effect as per detailed outlined in the Establishment Division’s O.M. dated 12-09-2009 (**Annex-I**). The new scheme also contains a provision that in case all the officers of Customs & Excise Group and Income Tax Group opt for new service, the Service will be renamed as “Pakistan Revenue Service”. The new Service shall become functional as soon as required formalities are completed and necessary modalities are worked out.

(b) Officers of (i) Customs & Excise Group and (ii) Income Tax Group.

(c) Yes. The Inland Revenue Service shall comprise only those officers who voluntarily opt to join this new Group.

(d) The seniority will be fixed in accordance with Civil Servants (Seniority) Rules, 1993, as amended from time to time. In case of anomaly, a committee comprising Additional Secretary —II, Establishment Division, Chairman. FBR and Additional Secretary, Law & Justice Division had been constituted to overcome the difficulty and interpretation of the methodology. The interpretation made by the Committee shall be final subject to approval of Establishment Division.

(e) The authority prescribed for appointment and promotion of officers/officials in respective Groups will continue to be as at present *i.e.* for BS-20 and above, the Prime Minister of Pakistan and for BS-17 to 19 Secretary, Revenue Division after due process of law.

OFFICE MEMORANDUM

**Subject.—TAX ADMINISTRATION REFORMS: REORGANIZATION OF
FEDERAL BOARD OF REVENUE - CREATION OF NEW
OCCUPATIONAL SERVICE NAMEDLY INLAND REVENUE
SERVICE.**

In terms of S.No.10.2.(i) of Schedule-II of Rules of Business,1973 and in continuation of this Division’s O.M. No.5/2/75-ARC dated 9-5- 1 975 and O.M.No. 4/2/75-ARC dated 9-5-1975. the undersigned is directed to say that in view of the ongoing Tax Administration Reforms that

include reorganization of Federal Board of Revenue, it has been decided to create a new Occupational Service namely Inland Revenue Service with immediate effect.

2. All the business concerning Income Tax, Sales Tax and Federal Excise currently being done by the officers and staff of Income Tax and Customs and Excise Groups is transferred to the new Inland Revenue Service. Existing Customs and Excise Group will be renamed as Pakistan Customs Service.

3. Federal Board of Revenue shall seek from each officer and staff of the existing Customs & Excise Group and Income Tax Group an irrevocable option for inclusion or otherwise into the new Inland Revenue Service. Such option once exercised shall be final. In order to facilitate the officers in this process, FBR shall apprise each officer (1) the number of posts which would form part of the new occupational service (2) upon option, the seniority in the new service shall count from the date of regular appointment in the present post in the existing Customs & Excise Group and Income Tax Group in accordance with Civil Servants (Seniority) Rules, 1993, as amended from time to time.

4. Upon receipt of requisite options. Federal Board of Revenue shall proceed as under:—

(a) **Scenario-I**

In case, some officers from the Customs and Excise Group and some officers from the Income Tax Group opt for Inland Revenue Service, the shortage of the Inland Revenue Service shall be met by posting of officers of Customs Group and defunct Income Tax Group under Section 10 of the Civil Servants Act, 1973.

Depending upon number of options to be exercised by the officers of Customs and Excise Group and Income Tax Group, the tentative cadre strength of new Inland Revenue Service and Pakistan Customs Service may be as under (*i.e.* equivalent to existing combined strength of the Income Tax and Customs and Excise Groups):—

Upon completion of exercise of options, the exact cadre strength shall be finalized by the Establishment Division in consultation with Revenue Division.

(b) **Scenario-II**

In case all the officers of the Customs and Excise Group and Income Tax Group opt for new Service, the Service be renamed as “Pakistan Revenue Service” with common seniority and doing all the revenue and tax business. All officers would be part of one cadre.

The tentative cadre strength of new service may be as under (*i.e.* equivalent to existing combined strength of the Income Tax and Customs and Excise Groups):—

Upon completion of exercise of options, the exact cadre strength shall be finalized by the Establishment Division in consultation with Revenue Division.

In both the scenarios mentioned in para-4 above, the Income Tax Group officers not opting for the new service, will remain in the existing Income Tax Group which will be a defunct and lying cadre without any future intake.

The inter se seniority of the officers of existing Income Tax and Customs and Excise groups exercising option for inclusion in the new Pakistan Revenue Service or Inland Service, as the case may be, shall count from the date of regular appointment in the present post in the existing Customs and Excise Group and Income Tax Group in accordance with Civil Servants (Seniority) Rules, 1993, as amended from time to time.

7. Other measures shall be taken as under:—

- (a) All the existing posts currently forming part of Income Tax Group as well as those meant for federal excise business but currently forming part of Customs and Excise Group shall form part of the new Inland Revenue Service with immediate effect. The said posts will, however, be transferred to the new Service upon completion of exercise of option.
- (b) Further recruitment to the existing Income Tax Group is stopped.
- (c) Effective from 2009, fresh recruitment to the newly constituted Inland Revenue Service or Pakistan Revenue Service as the case may be, shall be initiated through Federal Public Service Commission.

8. Establishment Division’s O.M. No. 5/2/75-ARC dated 9-5-1975 and O.M.No. 4/2/75-ARC dated 9-5-1975 regarding constitution of existing Income Tax and Customs and Excise Groups shall be deemed to have been modified to the above extent. In case of inconsistency between the provisions of said O.M.s dated 09-05-1975 and this O.M., the provisions of this O.M. shall have the over riding effect.

9. To overcome the difficulties and interpretation of the methodology an Anomaly Committee is constituted comprising Additional Secretary-II, Establishment Division, Chairman, Federal Board of Revenue and Additional Secretary, Law and Justice Division whose interpretation shall be final subject to approval of Establishment Division.

10. The Anomaly Committee and all others concerned shall ensure that the decisions contained in this O.M. do not create any administrative complications.

142. ***Mir Hasil Khan Bizenjo:** (Notice received on 03-08-2009 at 14:30 p.m.)

Will the Minister for Finance and Revenue be pleased to state:

- (a) *whether it is a fact that a monthly special allowance equal to one month's basic pay is being paid to the officers/officials of FBR, if so, the category of posts/employees who are entitled for this allowance; and*
- (b) *whether there is any proposal under consideration to the Government to grant another special allowance equal to one month's basic pay to the employees of the Board, if so, its details?*

Ms. Hina Rabbani Khar: (a) The Special Allowance, equivalent to 100% of the basic salary, is allowable to the officers and officials of the Federal Board of Revenue subject to their acquiring necessary skills, qualifying of test/interview and integrity test it is part of reform process at the Federal Board of Revenue.

(b) The government is not considering any proposal to grant another special allowance equal to one month's basic pay to the employees of the board.

143. ***Dr. Muhammad Ismail Buledi:** (Notice received on 04-08-2009 at 10:40 a.m.)

Will the Minister for Commerce be pleased to state the number of persons posted abroad by the Ministry of Commerce during the last three years with province-wise break up?

Makhdoom Amin Fahim: Total 118 persons have been posted abroad by the Ministry of Commerce during the last three years. Their details with province-wise break-up are at Annex-I.

144. ***Dr. Muhammad Ismail Buledi:** (Notice received on 05-08-2009 at 09:55 a.m.)

Will the Minister for Finance and Revenue be pleased to state:

(a) *whether it is a fact that the tax/duty has been levied on the saving accounts of widows and students; and*

(b) *whether it is also a fact that tax has been levied on drawal of an amount of more than 25 thousand Rupees?*

Ms. Hina Rabbani Khar: (a) Saving Accounts are subject to withholding tax under section 151 of the Income Tax Ordinance 2001. The law does not specifically provide for exemption of saving accounts of widows and students, however clause (59) of Part-IV to the Second Schedule provides exemption for income / profit on Post Office Saving Accounts and National Saving Accounts, if deposit in such account does not exceed one hundred and fifty thousand rupees. If the total income is taxable, then the tax is payable at the time of filing of return.

(b) Yes, withholding tax @ 0.3% is levied on cash withdrawal from a bank account, under section 231A of the Income Tax Ordinance 2001, if the said withdrawal exceeds Rs.25,000/- in a day

Makhdoom Amin Fahim: (a) No, it is not a fact. The data of Federal Bureau of Statistics (FBS) reveals that Pakistan did not export rice to India during the year 2007-08 and 2008-09.

Minister Incharge of the Cabinet Division: (a) Yes. It is a fact that some roads, footpaths and green belts in Islamabad have been blocked by Marriot and Serena Hotels for public parking and accessibility due to security reasons.

(b) No payment/rent is being charged from these Hotels for use of the roads and footpaths.

Will the Minister for Finance and Revenue be pleased to refer to senate starred Question No. 5, replied on 29th April, 2009, and state the present status of the case pending before the Supreme Court of Pakistan regarding payment to depositors of Indus Bank Limited (IBL)?

Ms. Hina Rabbani Khar: Supreme Court in its judgment dated May 13, 2009 has upheld the stance of SBP regarding the cancellation of license of Indus Bank Ltd, Under liquidation (IBL U/L) and has set aside the judgment of Sindh High Court dated July 11, 2002.

Peshawar High Court had earlier appointed three Joint Official Liquidators but two of them have left for various reasons. SBP is initiating request before Peshawar High Court to allow the sole liquidator to monitor the affairs of the bank (under liquidation). Once the Peshawar High Court grants the approval, the liquidator would start making payments to the depositors after mobilization of the assets.

(b) The procedure for evaluation of seized/confiscated goods is as under:—

- (i) Value of seized goods is determined by Valuation Department under Section 25 of Customs Act, 1969. The value of goods is calculated on the basis of evidence of import value of similar goods available with department. Then the appraising staff appraises the value of seized goods and after adding the due taxes final the Reserved Price (RP).
- (ii) The goods/vehicles are put to open public auction after advertising in the newspapers and the highest bid offered is accepted and in some cases the goods are sold to the authorized government departments.

(b) Overall performance of mobile operators is satisfactory; however, companies which fail to meet the set. (Qos), quality of service are proceeded against in accordance with rules and regulations. A fine of Rs.60 million was imposed on M/s. Mobilink due to provision of substandard services and the company was directed to compensate its subscribers with the same amount.
