(*Def*) \*Question No. 33 **Senator Haji Hidayatullah Khan:** (Notice Received on 23/02/2022 at 11:25 AM) QID: 38732

Will the Minister for Railways be pleased to state:

- (a) whether it is a fact that the Federal Government has recently purchased 20 rail engines from defaulted / defective locomotives companies, if so, the names of foreign companies and details of the procedure for purchasing engines thereof; and
- (b) the number of the functional railways engines of said foreign companies and details of its off track engines?

**Khawaja Saad Rafique**: (a) Ministry of Railways has purchased the undermentioned 20 Nos. D.E Locomotives in 2017 from M/s. General Electric Transportation Co. USA. (Now, M/s. WABTEC Transportation Co. USA, copy of signed papers is attached as **Annexure-A**).

The firm is not a international defaulter for manufacturing of locomotives nor a defective Company.

## **Procedure for purchase:**

For purchasing of locomotives, International Tender was advertised by the Director Procurement, Islamabad following the PPRA

Rules Nos. 12, 13 and 36 on Two Stage - Two Envelope bidding procedure basis.

After fulfilling all the pre-requisites as per Rules and Regulations, Director / Procurement, Islamabad finalized the case and the said Locomotives were procured from the above mentioned firm.

(b) At present, all the 20 Nos. D.E Locomotives are in working condition and none of them is stabled on any account. The reliability, availability of this particular fleet has mostly remained above 95% against the bench mark of 85%.

(The Purchaser and the Seller are collectively referred to as the "Parties" and on as individual basis as a "Party")


#### WHEREAS
