# (*Def.*) \*Question No. 6 **Senator Mushtaq Ahmed:** (Notice Received on 22/08/2022 at 4:25 PM) QID: 39654

Will the Minister for National Food Security and Research be pleased to state:

- (a) comparative details of federal excise duty and retail prices of locally manufactured and imported cigarettes;
- (b) the steps being taken for protection of local tobacco industry against the multinational tobacco companies in the country; and
- (c) the steps being taken for enhancing the market shares local tobacco companies in Pakistan?

Mr. Tariq Bashir Cheema: (a) Tobacco Industry has been subjected to Sales Tax @17% on retail price. Tobacco Industry is chargeable to Federal Excise Duty (FED) in term of Sr. No. 09 and 10 of First Schedule to the Federal Excide Act, 2005. FED on cigarette is imposed on multi-tier basis on the basis of retail price since 12-06-2013. Rates of FED have been enhanced from time to time. The details of FED imposed per thousand cigarettes from 01-07-2021 are attached as Annex-A.

Imported Cigarettes are subject to Sales Tax @17%. FED is chargeable @ 65% of retail price (as prescribed in S. No. 9 of schedule

whichever is higher) on imported cigarettes in terms of S. No. 8 to First Schedule to the Federal Excise Act, 2005.

The details of retail prices of the tobacco products, the retail prices of locally manufactured cigarettes as received from top tobacco companies of Pakistan is attached as **Annex-B**.

- (b) All tobacco companies either local or multinational have equal chance to indicate their requirement as per their own financial resources. M/o NFS&R and its attached department *i.e.* Pakistan Tobacco Board (PTB) does not engage in any commercial or trading activity or providing any financial support or facility to any tobacco company engaged in tobacco business. PTB provides equal opportunity to all players in the tobacco market as per law.
- (c) M/o NFS&R and its attached department *i.e.* PTB has no role in allocating market share to any tobacco company either multinational or local. Every tobacco company in Pakistan, operates its business regarding sale purchase of tobacco or cigarette manufacturing as per their own resources.

Will the Minister for National Food Security and Research be pleased to state:

- (a) the volume of production, consumption and shortfall of wheat in the country during the current year; and
- (b) the steps being taken for uniform wheat prices across the country during the current fiscal year?

**Mr. Tariq Bashir Cheema:** (a) Production, consumption and shortfall of wheat during the current year is reported as:

Initially a shortfall of 3 MMT was assessed. Later on, after the re-verification of carry-forward stocks and stock position the net shortfall was reported at the level of 2.60 MMT. Source: CRS, PASSCO and Provincial Food Departments.

- (b) Government is committed to announce the profitable support price before the next wheat sowing season. In this context following steps are being taken to announce a uniform support price of wheat 2022-23:
  - 1. API has worked out cost of production of wheat crop.
  - 2. Meeting of Wheat Board was convened on 30-06-2022 to sensitize provincial governments on the issue of support price of wheat.
  - 3. Follow up letters were sent to provinces on 23-06-2022, 3-07-2022, 03-08-2022 and 19-07-2022, with the request to submit endorsement of their respective Cabinets.
  - 4. API arranged a consultative meeting on wheat crop with all stake-holders.
  - 5. Cost of production was circulated among all stakeholders on 05-09-2022.

- 6. A meeting of Agriculture Task Force was convened in the PM Office on 15-08-2022 and a Sub-Group was constituted to formulate recommendations on wheat crop.
- 7. A meeting under the Chairmanship of the Federal Minister for NFS&R was convened on 26-08-2022, wherein provinces were reemphasized to submit the endorsement of their Cabinets.

# \*Question No. 71 **Senator Engr. Rukhsana Zuberi:** (Notice Received on 24/08/2022 at 3:19 PM) QID: 39660

Will the Minister for Maritime Affairs be pleased to state:

- (a) the date of construction and operationalisation of Gwadar Sea Port indicating the firms / individuals to whom lands were allotted in 5 km radius of the Port; and
- (b) the details of basic facilities including warehouses, roads, railway line, electricity and water available on the said port?

**Syed Faisal Ali Subzwari:** (a) The construction of Gwadar Port was completed in 2004 and the operation of port was handed over initially to M/s. Port of Singapore Authority on BOT basis for a period of 40 years in February 2007. This agreement was transferred on 18th February, 2013 and the Port was handed over to M/s. China Overseas Port Holding Company Limited (COPHCL), the term expires on 2047.

The 2283 acres area of Gwadar Free Zone land was handed over in 2015 to M/s. Gwadar Free Zone Company Limited for establishment of Free Zone in 5 km radius vicinity of the port.

### (b) Warehouses:

There are four warehouses in GPA Business Complex, (4,000 Sq Meter each = 02 No. 2,000 Sq. Meter each =02), and COPHC's 6,000 Sq Meter =01, excluding various warehouses of Gwadar Free Zone Company Limited.

### Road:

The access road of Gwadar Port *i.e.*, 19 KM Eastbay Expressway (EBEW)'s completed in June 2022, which directly connects the Makran Coastal highway with Gwadar Port.

# **Railway Line:**

The land for railway line is reserved along with EBEW from Coastal High Way to Gwadar Port, which needs to be constructed by Pakistan Railways. Recently EBEW has been inaugurated by Honorable Prime Minister of Pakistan on 03rd June, 2022.

### **Electricity:**

The total installed power generation capacity is 12.3 MW at Gwadar Port premises, with breakup of 4.5 & 7.8 HW power plant diesel / operational.

### Water:

Two sea water desalination Plants with 0.1 MGD and 0.264 MGD output are functioning at Gwadar Port. Third 1.2 MGD water desalination plant is under construction, which is expected to be completed by March 2023 and the total water production capacity will be enhanced to 1.564 MGD at Gwadar Port.

Mr. Asad Mahmood: The construction of one RCC Bridge and multi cell culverts on National Highway at Talash and Shamsi Khan in

District Lower Dir (Dir - Chitral Road N-45) has already been approved and is at procurement stage (Annex-A).

The construction period for the said works is one year. The work is expected to commence within three months *i.e.* after completion of procurement process as per law PPRA Rules and PEC guides lines.

Will the Minister for Foreign Affairs be pleased to state:

- (a) the number of Pakistani prisoners in China;
- (b) steps being taken for their release; and
- (c) the number of prisoners exchanged/released so far?

**Mr. Bilawal Bhutto Zardari:** (a) As per available record, 236 Pakistani prisoners including three women are confined in prisons under the jurisdiction of various Missions in China.

- (b) In pursuance of the Treaty of Transfer of Sentenced Persons between Pakistan and China that entered into force in October 2020, the process of transfer has started. A formal request for the transfer of first batch of 21 Pakistani prisoners was submitted to the Chinese Ministry of Justice in March 2022. Pakistan Mission is constantly in touch with the Chinese authorities for an early approval of transfer of first batch.
- (c) In the last 3 years, 18 Pakistani prisoners have been released from Chinese prisons after completing their sentences.

Will the Minister for Federal Education, Professional Training, National Heritage and Culture be pleased to state with reference to question No. 64 replied on 19th November, 2021:

- (a) the details of the referenced decision by the Ministry of Finance for grant of higher time scale to 90 left over female teachers of Federal Directorate of Education in BS-18 with immediate effect and not from the date of eligibility; and
- (b) whether there is any proposal under consideration for removing the anomalies created by the said decision between the teachers who were granted higher time scale with date of eligibility and those who were granted higher time scale with immediate effect, if so, details thereof and if not reasons thereof?

**Rana Tanveer Hussain:** (a) M/o FE&PT's requested Finance Division for guidance regarding effective date for grant of higher time scale before the meeting of DPC in February 2020. In this connection, Finance Division advised to grant HTS with immediate effect instead of retrospective date *vide* letter dated 02-03-2020 (**Annex-I**).

(b) The matter is subjudice and pending in Honorable Islamabad High Court in Appeal No. 2322/2020 (**Annex-II**). Moreover, grant of Higher time Scale is policy matter and amendment in the subject rules rests with M/o FE&PT and Finance Division.

Mr. Bilawal Bhutto Zardari: Pakistan's bilateral relations with Malaysia have witnessed upward trend. This was reflected in exchange of visits at the highest political level and signing of important agreements. During these visits MoUs in various sectors and other important agreements/treaty were signed.

A salient feature of enhanced bilateral interaction at the official level was initiated in Islamabad by convening the Inaugural Session of Bilateral Consultations at Foreign Secretaries Level. Malaysia has been extending support to Pakistan to graduate to ASEAN's Full Dialogue Partnership. It also provided valuable support to Pakistan on FATF. Prime Minister Mahathir criticized India's illegal actions of 5 August 2019, during his address at United Nations General Assembly in 2019.

Bilateral trade between the two countries saw remarkable uptick as Pakistan's exports increased to US\$460 million (highest figure ever) in 2021-22 taking total trade volume to US\$ 1,723 million.

**Mr. Ehsaan-ur-Rehman Mazari:** Government of Pakistan is committed for the promotion of sports including hockey in the country. In pursuance of this goal the Federal Government through Pakistan Sports Board provides administrative, technical and financial support to these games.

To the extent of hockey, the government has taken following steps for the improvement of performance and International ranking of national team and overhaul of domestic hockey structure

- The Government has provided Rs. 9 million to Hockey Federation as Annual Grant during the last five years (Annex-"A").
- The Government has also released an amount of Rs. 3.5 million and under the PM directive 7.3 million to PHF as a Special Grant (Annex-"A").
- An amount of Rs. 5.5 million was released to Pakistan Hockey federation for training cum competitions. Pakistan

Sports Board also established National Hockey Training Camps and incurred around Rs. 7 milion. (Annex-"B").

- Service of Foreign Coach for the period 21-11-2021 to 30-04-2022 (05 months & 10 days) amounting to US\$42,667 is also being provided (Annex-"B").
- The government has recently laid down synthetic hockey Turfs at Islamabad and Quetta. Whereas, work regarding lying of turfs in Wah Cantt. Peshawar, Abbottabad, Faisalabad and Muzaffarabad are under process.
- The Government is also introducing new governance system and National Sports Policy for the overhauling of sports structure including hockey in the country.

- i. National oilseeds Enhancement Program.
- ii. Productivity enhancement of Wheat.
- iii. Productivity enhancement of Rice.
- iv. Productivity enhancement of sugarcane.
- v. Cage Culture Cluster development Project.
- vi. Pilot Shrimp Farming Cluster development Project.
- vii. Promotion of trout farming in northern areas of Pakistan.
- viii. PM initiative for Save the Calf.
- ix. Calf Feedlot Fattening in Pakistan.
- x. PM initiative for Backyard Poultry.
- xi. National Program for improvement of watercourses in Pakistan (Phase-II).
- xii. National program for enhancing command area in Barani areas of Pakistan.
- xiii. Conservation and efficient use of water in Barani areas of KP.

All these above projects are focusing to uplift farmers across the country. Details are enclosed in **Annexure-A.** 

### National Oilseed Enhancement Program (NOEP)

This project was approved by Executive Committee of the National Economic Council (ECNEC) in its meeting held on 29-8-2019 at a total cost of Rs. 10963.883 million for a period of 5 years (2018-224). This project is part of Prime Minister Agriculture Emergency Program. Project funding is based on 40% by Federal PSDP and 60% by Provincial ADP. The project is being implemented in all four provinces (Sindh Component has so far not come on board as yet).

- 2. This project is providing subsidy of Rs. 5000/- per acre on sunflower, canola and sesame crop cultivation. Besides project also provide 50% subsidy on oilseed machinery.
- 3. The progress on the targets and achievements during 1<sup>st</sup> three years of the project are as under:

- (b) the reported losses suffered by small farmers during the recent floods; and
- (c) the steps being taken for rehabilitation of small farmers affected by the recent floods?

**Mr. Tariq Bashir Cheema:** (a) 90 percent of overall farmers (7.4 million) are categorized as smallholder farmers in Pakistan who own less than 12.5 acres of land.

- (b) Preliminary losses suffered by the farmers are around Rs. 529.1 billion as reported by the provinces.
- (c) The main exercise to rehabilitate the flood affected people is being done by the Ministry of planning, Development and reforms along with development partners *i.e.* World Bank, agricultural Development Bank, FAO and the UN agencies.
  - ➤ M/o NS&R has proposed for distribution of wheat seeds and oilseeds to support flood affected areas. According to provincial estimates about 4.07 million acre damaged due to recent floods. Most of the damage occurred in sindh and Balochistan followed by Punjab and KPK.
  - ➤ To give 100% coverage to support farmers for wheat seeds an amount of Rs 20.54 billion will he required. It was proposed that Federal & Provincial governments will share the cost with 50:50. However, Consent of the Provinces for sharing of cost is still awaited.
  - ➤ Meanwhile, Federal government has arranged Rs. 8.00 billion from its own development project for the provision of wheat seed. Mechanism for disbursement of seed is being finalized.

- (a) whether it is a fact that National Highways Authority (NHA) has a 20-years agreement with M/S More, a subsidiary of the Frontier Works Organization (FWO) according to which FWO increases toll tax by 10 percent applicable from August 26 every year, if so, the details of this contract; and
- (b) total amount of toll tax collected by FWO under the said contract so far, indicating also the details of projects executed/ completed by FWO during the said period under the said contract?

**Mr. Asad Mahmood:** (a) National Highway Authority (NHA) has undertaken the 20-Years Concession Agreement with M/s MORE, a project company formed by Frontier Works Organization (FWO) to execute the project "Overlay 86 Modernization of Lahore-Islamabad Motorway (M-2)" on Build Operate Transfer (BOT) Basis. The Concession. Agreement was signed between the two parties on 23rd April, 2014 for a period of 20-years. Under the concession agreement, the following annual toll escalation is applicable during the Operation Phase of the project:

- i. Ten percent (10%) annual Toll escalation shall be applied from the second (2nd) operational year till the twelfth (12th) year of the Concession Period *i.e.* till 2026;
- ii. Seven percent (7%) annual toll escalation shall be applicable from thirteen (13th) year of the Concession Period till last year of the Concession Period *i.e.* till 2034.
- (b) From 26-08-2022 to 25-08-2023 the detail of increased Toll tax is placed at **(Annex-A)**. The Concessionaire has conveyed *vide* NHA letter No. (203)/GM(M-2)/NHA/2022/660 dated 28-09-2022, however, the same is still awaited. The detail will be provided as soon as received from concerned quarter.

Will the Minister for Foreign Affairs be pleased to state the existing broad contours of Pakistan's foreign policy toward China during the last four years?

**Mr. Bilawal Bhutto Zardari:** Pakistan and China enjoy excellent broad-based and long-term relationship characterized by feelings of mutual trust, respect and goodwill towards each other. As close friends and partners, both countries have multi-faceted bilateral cooperation in diverse fields such as in economic, political, defence and cultural areas.

Pakistan's foreign policy towards China has been gaining momentum through sustained engagements between the leadership, extension of diplomatic support at multilateral fora and careful nurturing of all facets of bilateral relations. There has been exchange of high-level visits despite constraints posed by COVID-19 pandemic.

In economic arena, China remains Pakistan's largest trading partner. In January 2020, Phase-II of the China-Pakistan Free Trade Agreement (CPFTA) was operationalized which liberalized trade and enhanced trade volume between the two countries. China also remains Pakistan's largest source of Foreign Direct Investment (FDI). We continue to broaden our economic cooperation through increasing investments from China, enhancing cooperation in agriculture sector and expanding market access for Pakistani exports. Bilateral trade in 2021 stood at US\$ 27.8 billion.

Apart from political, economic and strategic relations, Pakistan and China also enjoy close cooperation in health sector. Pakistan and China extended support to fight against COVID-19 pandemic through provision of medical relief goods and strengthen Pakistan's capacity to fight COVID-19.

We also enjoy close collaboration in defense and security domain and frequent meetings at the highest level. Comprehensive public diplomacy strategy includes promotion of cultural exchange, people-topeople relations, tourism programmes and multitude of other outreach initiatives.

Will the Minister of Communication be pleased to state the deadlines on which the main damaged bridge over Hub River on the point connecting Sindh, Balochistan and other damaged bridges on Regional Cooperation Development Highway from Quetta to Karachi will be repaired and operationalized?

Mr. Asad Mahmood: • It is intimated that recent spells of Monsoon 2022 in July & August, 2022 resulted into massive flood damages in West-Zone especially in Hub-Uthal-Bela Section of National Highway N-25 resulting in collapse of Hub Bridge. Hub Bridge was

constructed in 1962 by Provincial Communication & Works Department, GoB. The field staff was available on sites and successfully carried out the temporary restoration works on emergent basis to ensure smooth flow of traffic. All the damaged sections of National Highways in Balochistan have now been temporarily restored and traffic has been resumed.

- It is further intimated that keeping in view urgency of the work in larger national interest, National Highway Council has accorded approval to carry out the permanent restoration works on G-2-G basis as per clause 42 (f) of PPRA Rules from state owned agencies. Moreover, NHA along with M/s FWO, M/NLC, PDMA and M/s NESPAK has already started carrying out joint survey of Flood Damages whereas Foreign Consultant through EAD/ADB will also carry out assessment / rehabilitation and fresh Hydrology/ Hydraulic study.
- M/s NLC has been awarded the work of construction of new Hub Bridge on 26th September 2022 and the time line to complete the said work is 18 months. Presently the work on detour of this bridge has been started by M/s NLC to facilitate the road commuters' (HTV / LTV) on temporary basis till the completion of construction on the new bridge and detour is expected to be completed within one month.
- In addition to above, it is further submitted that during this devastating flooding of 2022, heavy structures of N-25 between Hub to Quetta which were constructed by C&W Department have also been critically damaged / collapsed which include Khanta Bridge at Km 116, Lunda Bridge at Km 121, 05 Nos. Culverts between KM 130 and Km 160, Sardi Wala Bridge at KM 216. These heavy structures have been extensively assessed by the NESPAK and are now under design phase as per the revised hydraulic study. NHA has requested NESPAK to submit the same within shortest possible time but no later than one month, so the same should go through execution phase by completing all procurement / codal formalities in the best interest of road commuters.

**Mr. Ehsaan-ur-Rehman Mazari:** The subject of sports has been devolved as a consequence of 18th constitutional amendment and the role of Federal Government has become limited. The Provincial Governments are mainly responsible for promotion of sports in their respective provinces. National Sports Federations are autonomous bodies and responsible to carry-out their sports activities at national and international level.

The Federal Government extends its technical and financial support through National Sports Federations. To the extent of providing sports infrastructure, the Federal Government has completed two projects *i.e.* laying of synthetic Hockey Turf and construction of Boxing Gymnasium at Quetta, Balochistan. Similarly, a project to rehabilitate and upgrade existing facilities of PSB, Coaching Center at Quetta having estimated a cost of Rs.379.311 million has been included in the current year PSDP.

Moreover, Government of Pakistan is committed for the promotion of sports in the country by providing administrative, technical and financial support to National Sports to raise the standard of sports.

- Tandliyanwala service area, Lahore Islamabad motorway (M-3)
- 3. **Dandewal service area,** Pindi Bhattian -Faisalabad, Khanewal motorway (**M-4**)
- 4. **Khanewal service area,** Pindi Bhattian Faisalabad, Khanewal rnotorway (**M-4**)
- 5. **Hazara service area,** Hassanabdal-Havelian Expressway (E-35).
- 2. Moreover, M/s MORE (Pvt.) Ltd. being the BoT concessionaire of M-2, has installed EV charging facility at Bhera Service Area on M-2.



#### SUMMARY FOR THE PRIME MINISTER

Subject: Appointment of Honorary Consuls in Pakistan

The Prime Minister had been pleased to direct that the Ministry of Foreign Affairs may review the policy regarding appointment of Honorary Consuls that had been generally governed by the criteria decided in January 2005 (Annexure'A'). The Ministry has accordingly re-examined the policy and has the following criteria/policy to recommend consistent with the customary practice and International Conventions:

- (a) The nominee should be a bonafide citizen of Pakistan.
- (b) The nominee's character, antecedents and social standing shall be cleared by the Ministry of Interior and security agencies.
- (c) Principle of reciprocity will prevail where a country has restricted or refused our request for appointment of Honorary Consul.
- (d) Nomination should be for the Federal Capital or the four Provincial Capitals only and, in exceptional cases, in important industrial/business centers of Pakistan. Nominations will be examined and cleared from a political point.
- (e) The consular jurisdiction of the proposed nominee should be clearly defined by the nominating State and have the approval of the Government of Pakistan.
- (f) Nomination of more than one Honorary Consul would be allowed only where justified by the importance of bilateral relations with the country concerned.

- The nominee should be proposed for appointment as Honorary Consul by only one foreign State. He should not hold a Consular Commission of another State.
- The individual who meets the criteria may be appointed for an initial period of five years and the appointment may only be extended on a clear request by the nominating State for an additional period of five years.
- The privileges and immunities applicable to an Honorary (i) Consul be strictly in accordance with the Vienna Convention on Consular Relations-1963 and any other condition that Pakistan may wish to impose by exercising its prerogative as a receiving State. An infringement should lead to our asking the nominating State to withdraw the assignment.
- There should be no conflict of interest in the official position, if any, held by the nominee and appointment as Honorary Consul/Consul General.
- There cannot be Honorary appointment in a city where the nominating State has official representation.
- There cannot be two nominations for one city. (1)
- Prime Minister's kind approval is solicited The recommendations contained in paragraph-2 above.
- The Foreign Minister is on tour abroad. .3.

- (a) the appointment of members of a consular post, their arrival after appointment to the consular post, their final departure or the termination of their functions and any other changes affecting their status that may occur in the course of their service with the consular post;
- (b) the arrival and final departure of a person belonging to the family of a member of a consular post forming part of his household and, where appropriate, the fact that a person becomes or ceases to be such a member of the family;
- (c) the arrival and final departure of members of the private staff and, where appropriate, the termination of their service as such;
- (d) the engagement and discharge of persons resident in the receiving State as members of a consular post or as members of the private staff entitled to privileges and immunities.
  - 2. When possible, prior notification of arrival and final departure shall also be given.

### SECTION II. END OF CONSULAR FUNCTIONS

#### Article 25

Termination of the functions of a member of a consular post

The functions of a member of a consular post shall come to an end, inter alia:

- (a) on notification by the sending State to the receiving State that his functions have come to an end;
- (b) on withdrawal of the exequatur;
- (c) on notification by the receiving State to the sending State that the receiving State has ceased to consider him as a member of the consular staff.

### Article 26 Departure from the territory of the receiving State

The receiving State shall, even in case of armed conflict, grant to members of the consular post and members of the private staff, other than nationals of the receiving State, and to members of their families forming part of their households irrespective of nationality, the necessary time and facilities to enable them to prepare their departure and to leave at the earliest possible moment after the termination of the functions of the members concerned. In particular, it shall, in case of need, place at their disposal the necessary means of transport for themselves and their property other than property acquired in the receiving State the export of which is prohibited at the time of departure.
