- 7. Robust Complaint Redressal system for public.
- 8. Dolphin Squad has been established on the pattern of Dolphin Force Punjab.

Please refer to part (b) of the Senate Question No. 90 by Dr. Zarqa Suharwardy Taimur vide reference number 14/14/2023-(Council)(333) dated 03.11.2023 communicated to the undersigned via WhatsApp on 06.11.2023 on the subject.

2. It is stated that in order to curtail the increasing incidents of terrorism, the Law Enforcement Agencies (LEAs) including CTDs and NACTA have been actively monitoring the situation. In this regard, the level of coordination between federal and provincial/regional governments is being strengthened to identify actionable areas for creation of harmony in counter terrorism efforts. In this regard, the input available in this Branch is as under:

Security Landscape

US troops withdrawal from Afghanistan and inaction of Interim Afghan Govt. (IAG) against TTP offered it an opportunity to increase its influence, presence and activities. During the Peace Talks, it reorganized and enhanced its operational outreach. It has given significant rise to its activities and is seeking support of other militant groups to increase strength and capabilities. It is mostly concentrated in KP especially Merged Districts with footprints in Balochistan and trying to activate its network in the country. Arrival of tashkeels of TTP in significant numbers continue in Merged Districts along with recruitment, training and placing of suicide bombers is a cause of concern. DAESH is also trying to establish foothold in Pakistan. It resorts to terrorist activities against Shias and trainorities to ignite sectarian strife.

Steps taken by the Government

Fencing Along Western Border

The work on the fencing along with the western borders of Pakistan has largely been completed to further strengthen the State mechanism of curbing the illegal movement from across the border. It is worth mentioning that the above-mentioned organizations, in particular TTP, continue to sabotage the fencing.

· Registration of Refugees

Among 1.4 million registered refugees, data of 1.45 million was updated and expanded as a result of DRIVE through issuance of smart identity cards. The cards contain basic information including biometric data and are compatible with the local systems. The rationale for the process of updation and documentation includes strict monitoring mechanism over the individuals involved in criminal and terrorist activities.

Dismantling the communication networks to combat online extremism

Pakistan Telecommunication Authority (PTA) remained active to effectively monitor cyberspace. A total number of 16522 complaints were forwarded to social media platforms for blocking of radical / sectarian, anti-state and terrorist content by Pakistan Telecommunication Authority during the year 2022.

There has been 136.4pc increase in overall compliance made by SMCs during the period under review as compared to 2022: the compliance rate during the first half of 2023 was recorded as 61.9pc as compared to 2022 when it was 26.2pc. Moreover, the data indicates that the compliance by Twitter has increased by 392.4pc, Facebook by 139.2pc and YouTube and Instagram by 72.7pc, in connection with blocking of content based on hate speech, radicalism, sectarianism and terrorism.

Steps taken by Counter Terrorism Departments (CTDs)

IBOs

A total number of 4892 Intelligence Based Operations (IBOs) were conducted against the elements associated with terrorist/separatist organizations by provincial Counter Terrorism Departments (CTDs) during the year 2022 in which 209 terrorists died and 1781 were apprehended. Moreover, a total number of 169 LEAs were martyred 284 were injured during these IBOs. Likewise, a total number of 3364 IBOs were conducted during Jan-June 2023, in which 172 terrorists died and 171 were apprehended.

The State has continued strict monitoring against the proscribed terrorist/extremist organizations while maintaining their profiles with respect to their strength, activities and movement.

Prosecution of terrorists

The prosecution of terrorists holds paramount significance in Country's fight against terrorism. During the year 2022, a total number of 2006 individuals in olved in terrorism cases were challaned and 218 were convicted while the remaining are under trial.

Capacity Building of CTDs

Specialized wings have been established in provincial Counter Terrorism Departments (CTDs) with special focus on cyberspace. Moreover, the respective provincial Home Departments have engaged the CTDs to analyze the trends of radical ideologies and countering the same. There are customized specialized wings in the CTDs that cater for their regional / provincial requirements that include five (05) specialized wings in CTD Punjab, nine (09) in CTD Sindh, six (06) in CTD KP, four (04) in CTD Balochistan.

Steps taken by NACTA

According to NACTA Act 2013 (Amended in 2017 & 2020), the Authority performs a number of functions pivoting around counter terrorism and extremism in coordination, policy-making and capacity building domains. The strengthening of National Counter Terrorism Authority (NACTA) remains the priority matter. The Amendments in NACTA Act, made in 2017 and 2020, aim to smoothen the functions of the Authority. Moreover, various branches, such as, the Outreach & CVE have been established in line with the evolving dynamics of extremism and terrorism.

The Authority has a robust mechanism of coordinating with the bodies countering terrorism/extremism at operational level. Moreover, the Authority provides a platform for the stakeholders to deliberate upon the CT & CVE policies. Following are the key contributions of NACTA:

Revised NAP (2021)

The National Action Plan was revised in 2021 after an inclusive consultative process with the stakeholders. More than sixteen hundred key performance indicators (KPIs) were notified for R-NAP. The old NAP comprised of twenty points, whereas the Revised NAP comprised of fourteen (14) points (05 kinetic domain, 09 non-kinetic/ policy domain) keeping in view the evolving security landscape. To review the implementation status of the R-NAP KPIs, NACTA's R-NAP Portal was launched in July 2022 to streamline the reporting mechanism from various federal and provincial stakeholders. It serves as consolidation of nationwide CT efforts done by law enforcement agencies including CTDs, Police, FIA, Prosecution Departments, PEMRA, ANF, PTA, SAFRON and others.

The Revised NAP 2021 consists of fourteen (14) points as enumerated below:

- Intolerance for Militancy No Militant/Armed/Identified Criminal Gangs be Allowed to Operate
- Action Against Spread of Terrorism Through Media (Electronic, Print & Social Media)
 Communication & Cyber Networks
- 3. Taking Effective Measures Against Religious / Sectarian Persecution & Terrorism
- 4. Choking of Terror Financing & Proscribed Organizations
- 5. Curb Increasing Trends of Illegal Spectrum (Narco, Weapons & Human Trafficking)

Non-Kinetic Domain

- 6. Follow up of Counter Terrorism (CT) cases in Courts to conclusive end
- 7. Capacity Building / Strengthening of CTDs
- 8. Formulation, Institutionalization & Implementation of CVE Policy
- 9. Regulation & Registration of Religious Seminaries / Madaris
- 10. Balochistan Reconciliation Process
- Merged Areas of KP Reforms (NFC, Capacity Building of LEAs, LG Elections & Land Reforms)
- 12. Reforms in Criminal Justice System (CJS).
- 13. Legislative / Legal Oversight for Espionage / Subversion
- 14. Repatriation of Afghan Refugees and dealing with their issues

Compendium of NACTA's Recommendations on National Action Plan

A compendium of NACTA's recommendations with respect to the implementation status of Revised National Action Plan has been compiled and shared with Central as well as Provincial/ Regional Apex Committees.

Maintenance of List of Individuals on Fourth Schedule

NACTA maintains a list of individuals on Fourth Schedule through a real-time data portal on NACTA's website whereby direct entries are made in the system through provincial/ regional home departments for addition and deletion. Any mismatch in the data is resolved through mutual discussion/ consultation among NACTA and home departments, including the State Bank of Pakistan (SBP) and Punjab Information Technology Board (PITB). This enables the relevant stakeholders to implement the measures and sanctions against proscribed individuals/ organizations in line with domestic and international legal regime.

Threat Assessments and Analysis

A comprehensive threat matrix that elucidates overall security spectrum; includes summary of threat alerts/information report/social media CT highlights is shared with all stakeholders for necessary action on monthly/quarterly/Bi-Annual/Annual basis. Since 2017, a total number of four (04) Annual, three (03) Bi-annual and ten (10) Quarterly Threat Assessment Reviews have been shared with concerned ministries/ depts/ Chief Secretaries/ federal and provincial intelligence agencies. Since 2017, 3091 Threat Alerts have been issued by NACTA.

Intelligence Coordination Conference (ICC)

ICCs are held at NACTA HQs on regular basis to ensure enhanced cooperation, improved coordination, timely exchange of information with all federal / provincial agencies and departments.

Counter Terrorism Helpline 1717 24/7

CT Helpline has been operational at NACTA on 24/7 basis since 2015 for receiving complaints/information about cases/incidents pertaining Terrorism and CT. Since 2015, a total number 6378 actionable calls were received. To that effect, a total number of 184 FIRs have been registered.

Terrorism Data

Terrorism data is being maintained at NACTA that encompasses total attacks, casualties and injuries (LEAs/civilians) caused in terrorist attacks since 2001. This data is used for analysis of emerging trends of security threats and to develop strategies and action plans.

Profiling of Terrorist Organizations (TOs)

A comprehensive profiling dossier of terrorist organizations detailing its genesis, operational background, capabilities and leadership has been compiled.

Monitoring the implementation of National Action Plan on annual and bi-annual basis

NACTA conducts reviews of the implementation of National Action Plan on annual and biannual basis. Moreover, the Authority has developed key performance indicators (KPIs) of Revised National Action Plan (R-NAP) 2021, in consultation with stakeholders for implementation of specific points of NAP. NACTA conducts reviews of the implementation of National Action Plan on annual and bi-annual basis. The latest version of the Biannual Review (2023) was published in August 2023 and was circulated among all stakeholders.

Developing Policies, Strategies & Action Plans

Following are the main policies, strategies and action plans developed by NACTA:

CFT Policy Framework

NACTA has been leading the efforts to implement measures by respective authorities to choke financing of terrorist organizations, splinter groups and affiliates. Key contributions of the Authority are as under:

- PM Approved Policy on Financial Investigations by LEAs issued in 2019 (update in progress)
- National TF Risk Assessment of 2018 & 2019 completed (NRA 2023 underway)
- Proposed amendments in ATA-1997 (FATF related gaps addressed)
- Multilateral MoU with 25 agencies to enhance exchange of information
- Guidelines on Implementation of UNSCR 1373 issued in 2018 and revised in 2020
- SOP on use of JITs in TF cases issued by NACTA (includes representation of SBP, FMU & FIA)
- SOP on the investigator-Prosecutor Cooperation in TF cases issued in 2019
- Various Directives issued by NACTA on: Investigation Wide Range TF Activities, International Cooperation in TF Matters, Guidance on Covid-19, Guidelines on Identification of Associates, Investigating Narcotics & Smuggling in Post Covid-19 Scenario, Fund Raising of Activities in Flood Victims, and on Branchless Banking to stop the potential misuse of Branchless banking for ML/TF purposes.
- Orientation and Capacity Building (1000+ officials including investigators, prosecutor and judges)
- · Raising of CFT Units in CTDs and capacity building with adequate trainings
- · Designing an e-learning portal for LEA personnel on AML/CFT regime in Pakistan
- Inter-agency coordination has enhanced meetings of the National Task Force on CFT, TF Sub-committee of the Task Force, provincial Coord Committees and JITs in TF cases.

Revised NAP Portal

The R-NAP Portal is mechanism of reporting from various federal and provincial stakeholders. It serves as aggregation of nationwide CT efforts done by law enforcement agencies including CTDs, Police, FIA, Prosecution Departments, PEMRA, ANF, PTA, SAFRON and others.

· Research on CT & CVE Issues

NACTA carries out research on topics relevant to terrorism and extremism and prepares and circulates documents.

Liaising with international entities for facilitating cooperation in CT & CVE Areas

NACTA is a key national stakeholder in the matters of Shanghai Cooperation Organization – Regional Anti-Terrorist Structure (SCO-RATS). Being member of Group of Legal Experts (GLE) of SCO-RATS, CT Branch provides regular input to Ministry of Foreign Affairs and participates in the meetings of GLE NACTA. Moreover, NACTA is one of the lead agencies with respect to CT dialogues with other countries/ organizations, such as US and EU. NACTA has also been influential in the monitoring visits of UN Monitoring Teams on CT related UN Security Council Resolutions.

Reviewing relevant laws and suggesting amendments to the Federal Government

NACTA conducts reviews of the existing legal framework and incorporates the input in annual and bi-annual reviews of National Action Plan. NACTA conducts reviews of the existing legal framework and incorporates the input in annual and bi-annual reviews of National Action Plan. Furthermore, NACTA is an active member of the Federal Sub-Committee on the Implementation of R-NAP in Legal, Organizational and Structural Domain. In this regard, reviews/ proposals on ATA-1997 Amendment Bill (2023) have been submitted to Ministry of Law and Justice. Moreover, NACTA has also proposed that CTDs be given investigative powers under PECA-2016.

· Outreach Activities for Prevention of Violent Extremism

NACTA conducts a number of preventive measures to counter the narrative of terrorism and extremism by engaging vulnerable segments of society i.e., women and youth. These include national posters contest, slogan writing competition, street art, youth awareness sessions among university students, awareness sessions for NPOs for safer charity, radio programs, shout-out messages, outreach session for Parliamentarians and Government Officers on CVE and video / audio messages based on key CVE themes to be disseminated in social and electronic media.

National Security Policy (2022-26)

The National Security Policy (2022-26) is being implemented that outlines the challenges being faced by the State including extremism. The Policy aims to leverage the symbiotic relationship among human, economic and military security with the safety of citizens as its principal focus.

National Policy on Preventing Violent Extremism

To augment the efforts of the State to counter extremism, NACTA has formulated a 'National Policy for Preventing Violent Extremism 2023' encompassing the trends, factors involved and subsequent measures needed to be taken to curb extremis. The Policy aims to apprise the stakeholders to take actions in a coordinated manner, by focusing on the phenomenon of extremism, its root causes and counter measures to eradicate the menace of extremism. The main objectives of the Policy are:

- · Identification of violent extremism trends & response
- Promotion of pluralistic values of peace, tolerance & diversity in society
- Progressive use of social, electronic, print media to prevent violent extremism
- Public engagement to improve social cohesion & resilience against violent extremism
- Protection of vulnerable communities against risks of violent extremism.

The policy is submitted before the quarter concerned for approval.

Revamping of NACTA

Strengthening of NACTA is underway in following areas:

CVE Unit

A Counter Violent Extremism Unit is being established within NACTA. Its function is to fight battle of narratives. Extremist narrative of the terrorist organizations will be suppressed with full force. Pakistan's national narrative shall be propagated by tising all means possible. Modern technology and equipment will be provided to the CVE Unit to create and spread messages of peace. Social media and internet will be monitored by the Unit and cyber-space will be denied to the extremist forces.

Fusion Center and Database

A Fusion Center is being established within NACTA which will have online connection with all LEAs. Two-way flow of information will be maintained to support the LEAs. An authentic database of terrorism and extremism is being built to support the Fusion Center. Data Scientists and Analysts will run the system.

Intelligence Analytics

Intelligence Wing is being re-organized with latest capacity of analysis of information. Timely and actionable intelligence will be provided to all stakeholders.

The revamping aims to make NACTA a Focal Point of Pakistan's Counter Terrorism efforts. It will guide and actively support all relevant stakeholders to rout out terrorism and extremism on sustainable and permanent basis.

Minister for Interior: It is noteworthy that the Capital Development Authority had developed a robust and comprehensive mechanism for the disposal of animal waste during the occasion of Eid-ul-Azha in the Islamabad Capital Territory (ICT). This mechanism included awareness banners highlighting the importance of proper disposal of animal waste, urging the public to play their role in the appropriate way of sacrifice on Eid-ul-Azha. Additionally, awareness has been generated regarding the proper disposal of animals through announcements from mosques, awareness pamphlets, and other means. To enhance awareness, various social media channels such as Twitter were utilized, and the helpline 1334, along with the Complaint number (0335-5001213) for WhatsApp and SMS service, remained operational 24/7 throughout the Eid-ul-Azha period, ensuring the effective resolution of any complaints.

Furthermore, the Directorate of Sanitation staff undertook special duties throughout all three days of Eid-ul-Azha, as all leaves for the personnel were revoked. This concerted effort has resulted in the proper disposal of animal waste through the successful generation of awareness.

Will the Minister for Interior be pleased to state whether CDA has taken any action against illegal housing schemes in Islamabad and its peripheries during the last three years, if so, the details thereof and if not, the reasons thereof?

Minister for Interior: As per Islamabad Capital Territory (ICT) Zoning Regulation 1992, Islamabad was divided into 5 Zones. Private Housing Schemes were allowed to be developed in Zone-2, 5, E-11 and selected locations of Zone-4 after seeking permission from CDA. Under these regulations, CDA has permitted number of private housing schemes in Islamabad. CDA has uploaded the status of approved housing schemes on its website www.cda.gov.pk. The layout plans showing plots numbers of each approved housing scheme can also be checked on CDA website.

- 2. There are number of housing schemes which have been developed without permission of the authority which are called illegal/unapproved/un-authorized housing schemes. List of all illegal housing Societies / Schemes in Zones 1, 2, 3, 4, and 5 in ICT is also available on CDA website. This list is updated on a regular basis.
- 3. The actions taken by CDA during the last (03) years is at Annexure-I.

ANNEX-I

- CDA has taken following steps to control the mushroom growth of illegal housing schemes in Islamabad;
 - Public Notices issued in newspapers from time to time, to warn general public about these illegal housing societies.
 - Public Notices uploaded on CDA website regarding illegal housing schemes.
 - A joint public notice published on 12/2/2021 in newspapers to warn general public.
 - iv) Notices issued to the sponsors of the schemes by CDA warning them not to make publicity / marketing / sale of plots and to refrain from making any construction in unapproved/ illegal schemes. Upon non-compliance, Show Cause Notices were issued.
 - v) Cases of illegal schemes in Sector H-17 (Zone-I), were forwarded to Magistrate, CDA, for action against the violator.
 - vi) Joint operations against the illegal scheme/ projects have been carried out by the Authority in coordination with ICT Administration, and Boundary Walls and illegal constructions were demolished. Site offices were sealed.
 - vii) A number of cases have also been registered against the sponsors of six (6) societies.
 - viii) The Authority has also requested IESCO, SNGPL and PTCL, that connections in the unauthorized / illegal housing schemes may not be provided till the provision of NOC from the Authority.
 - SSP (Operations), ICT, has been provided a list of illegal/unauthorized Housing Societies/Schemes to take action against them.
 - A joint operation was carried out on 26-05-2021 and offices of 11 illegal housing schemes and projects being constructed without permission were sealed and the work was stopped.

Minister for Interior: (a) There was no partial collapse of Bhara Kahu Flyover rather two incidents occurred at the project during construction activities at site. The first incident was fall of transom during pouring at pier No. 10 due to hitting of shuttering / formwork of the transom by oversized / overloaded vehicles at night time. The incident resulted in casualty of two labourers. The second incident was fall of Girders from the span No. 01 during launching operation wherein no loss of material or human life happened.

- (b) The Prime Minister Office has constituted a high level inquiry Commission under Section 3 of Pakistan Commission of inquiry Act 2017, comprising Mr. Shahid Khan, former Secretary Ministry of Interior to probe the matter of collapse of shuttering and Girders of under construction Bhara Kahu Bypass project The TOR of the commission also include that the commission shall fix responsibility of the incident. Outcome of the Inquiry Commission is yet awaited and CDA will accordingly take action against the Contractor and Consultant if such responsibility is fixed by the commission followed by other actions upon recommendation of the commission.
- (c) As of now, the inquiry commission has not fixed any responsibility on the functionaries. Action in this regard will also be taken once the Commission finalizes its report and fixes such responsibilities.

Minister for Interior: (a) Yes Following are the reasons for withdrawal of Police Officials from FST:

- 1. Due to country-wide protest movement by the political maintenance of Law & Order.
- 2. FC Officials were temporarily deployed at Federal Shariat Court.
- 3. No threat concerns were highlighted from any source against Federal Shariat Court.
- 4. Federal Shariat Court is located in the Red Zone which is a gated area. Wider measures were taken to enhance the security at Red Zone/High Security Zone (HSZ).
- 5. In Annual Policing Plan 2022 of Islamabad Police there is no provision of sanctioning of separate manpower for security of Federal Shariat Court.
- (b) Yes Due to above cited reasons Police personnel are not deployed. However, the matter has been referred to Threat Assessment Committee (TAC). The forum consisting of members of LEAs and Police shall submit recommendations after thorough analysis of the threat, for further necessary action.

Minister of Interior: Water Supply Scheme Tramri, ICT Islamabad is functional and working, which is providing drinking water facility to the inhabitants of the area under supervision of Water User Committee of local/Union Council Tarlai.

Water Supply Scheme Alipur Farash is functional and one new tube well is installed for extension of water supply scheme Alipur Farash for which electric connection is pending with IESCO.

Water supply scheme Tarlai: Water table has draw down in the existing tube well, two further trial bores were made but there is no water found in the area

Chatta Bakhtawar and Sathra meel: no water supply scheme exists in these areas.

Chak Shahzad: CDA has informed that regular water supply is being provided on daily basis from Water Supply Directorate, CDA to Chak Shahzad Town Islamabad, because the said area is under the control of Capital Development Authority, Islamabad.

(b) The Local & Rural Government Department, ICT have no such infrastructure for water supply through water tankers. However, CDA is providing portable water to the sectorial area as well as model villages (Shahzad Town, Margalla Town, Rawal Town) through water tanker. Moreover, regular water supply are being provided on daily basis

from Water Supply Directorate, CDA including Chak Shahzad Town, Islamabad, because these areas are under the control of Capital Development Authority, Islamabad.

Will the Minister for Interior be pleased to state whether it is a fact that flats constructed for Government employees in Sector G-6, near Abpara Market, have illegally been occupied by trespassers, if so, the action taken by the Government in the matter so far?

Minister for Interior: Yes, as per record, 200 flats constructed by CDA in Abpara Sector G-6 are illegal occupied by ICT Police Officials and other Federal Government Departments. The authority has taken up the matter with quarter concerned for handing over the possession of said flats to CDA (Annex-I). However, illegal occupants got status quo. The Authority has also contested the matter before the Honorable Islamabad High Court. The matter was finally decided by the Honorable Islamabad High Court, Islamabad in ICA 109/2011 vide order dated 13-02-2023 (Annex-II). The operative part of the judgment is reproduced as under:

"The Inspector General of Police as well as Secretary, Ministry of Interior are directed to register the criminal cases against all the officials/ employees of police department, who have illegally occupied the flats by force with further directions to Inspector General of Police, Islamabad to initiate departmental action against all the occupants on departmental side and shall submit a compliance report before this Court within period of one (01) month, failing which, Secretary Ministry of Interior and Inspector General of Police, Islamabad shall be dealt strictly in accordance with the law."

In the light of aforementioned order of Honorable Islamabad High Court, Islamabad dated 13-02-2023 the matter was taken up with ICT Wing, Ministry of Interior, Government of Pakistan with request to pass directions to IG Police Islamabad to handover the possession of CDA flats at Sector G-6. Islamabad to CDA to enable the Authority to further allot the accommodation in question to its employees who are waiting for the same for so many years (Annex-III). Reminder in this regard was also issued to ICT Wing, Ministry of Interior, Government of Pakistan vide letter dated 20-09-2023 (Annex-IV). In response to the CDA letter Ministry of Interior has taken up the matter with Ministry of Housing and Works and Chief Commissioner Islamabad. Ministry of Housing endorsed the directions of Hon'ble Islamabad High Court, Islamabad. Finally Ministry of Interior has issued directions to the Inspector General of Police Islamabad for compliance.

VACATION OF G-6 FLATS, ILLEGALY OCCUPIED & TRESPASSED

BY ICT POLICE OFFICIALS.

Dear Sir.

I am directed to refer to the subject noted above and to state that the Cabinet had decided in its meeting dated 13.93.1995 to re-devalop the Sector G-6. In order to initiate the process, CDA was directed to construct 200 Nos A-Type multi story flats on open land svailable at the three different locations in sector G-6. The work was started in June 1995 with a completion period of 18 months. CDA spent an amount of Rs.151 million for the construction of 200 flats in G-6, Islamabad as directed by the Government. The flats were completed in August 2003. The flats were constructed as alternate accommodation arrangement of detracted accommodation of old A&B quarters in sector G-6 which were to be demolished for construction of new Government accommodations. But the schame could not be matured for one or the other ressons for considerable time. These flats were occupied by Earthquake effectess in October, 2005 which were got vacated in January 2007.

- 2. During the year 2007, the incident of Lat Masjid operation took place in islamabad and it was decided that all the police officials be accommodated in the vecant residential accommodations due to presence of police in the vicinity of Lat Masjid round the clock. Afterward, the situation changed, these officials rafused to vacate these flats and a series of litigation started. The Honorable supreme Court has recently in its judgment remanded back these cases to Honorable islamabad High Court.
- 3. It is a matter of fact and evident from record that CDA is sole owner/proprietor of Land and constructed flats. Neither Ministry of Housing bothers to pay including land and construction cost nor any rental ceiling to CDA. Even that CDA deprived its own bonefide employees from the legitimate mimodation, having a large numbers of employees on its strength. At consent, majority of flats have been occupied by Islamabad Police, About 130 and again occupants from Islamabad police are residing in these flats.

ting Committee on Housing & Works, it was directed by the Committee that for Police Department may be asked to immediately vacate these flats from their officials and necessary disciplinary proceeding should also be initiated against these illegal occupants of the flats.

6. It is therefore requested that kindly direct your officials to vacate immediately these trespassed flats and hand over their peaceful possession to CDA Enquiry within a weak time. List of illegal occupants / trespasser of your department officials has already been provided by the Estate office. An early compliance of the Sub-Committee on Standing Committee of (H&W) of Nation Assembly Government of Pakistan's directions will highly be appreciated.

MOHSIN AKHTAR KAYANI, J: By way of this common judgment, we intend to decide all the captioned Intra Court Appeals as having common

In all these appeals, the appellant CDA have assailed the order dated 13.04.2011, passed by learned Judge in Chambers, whereby the writ petitions filed by the respondents police officials, were allowed with the following observations:-

One of the contentions of respondents is that the petitioners had forcibly occupied Govt. accommodations and if the same are regularized, then it would become regular practice that people will forcibly occupy Govt. accommodation and then approach the Court for regularization of allotment. It was, therefore, submitted that petitioners be asked to vacate the accommodations first. This controversy cannot be resolved at this stage for the reason that the contention of petitioners is that they were in permissive possession of the houses, as because of law and order situation they had been accommodated in the disputed houses. In order to resolve the controversy, evidence would be required, which is not possible in writ jurisdiction. The only argument of the respondents is that since the petitioners are not in possession of any allotment order, therefore, they

are trespassers. Although, there is no allotment order in possession of the petitioners, yet in view of their own contention, it cannot be held that they had forcibly occupied disputed houses. Furthermore, the learned Deputy Attorney General contended that at the time of Lai Masfid operation, they were not allotted houses, rather the police officials were

accommodated for certain time and their families were never accommodated in these houses. This assertion too, would require evidence for proof. Moreover the same is indirect admission of permissive possession. There is however, no denial of the fact that there is no proper allotment order in favour of petitioners and the grievance of petitioners regarding proper allotment order is required to be settled once for all.

In vieto of the above mentioned facts, the respondent No. 2 & 3 are directed to consider the applications of the petitioners for allotment of residential accommodation with effect from the date each petitioner is in possession of the respective accommodation. The petitioners be treated at par with all other police employees of the same category, who have been allotted houses. In the above terms, these writ petitions stand disposed of

3. Learned counsel for the appellant CDA contends that the respondents police officials have forcibly occupied the flats under the garb of Lal Masjid operation, constructed by the CDA, despite the fact that those flats have never been allotted to the police officials neither they are eligible under any law to retain the possession of the subject flats. It has further been contended

- 8. It has not been deried by the Police Department that the apex court in HRC Nos.20746, 30827-P, 30588-S and 30001-K/2018 has passed the orders for vacation of all the government quarters of Estate Office from the employees of Police Department on the statement of Inspector General Police as the police officials are not eligible to retain the Government Accommodation in terms of Accommodation Allocation Rules 2002.
 - 9. We have gone through the judgment rendered by the learned Judge in Chambers, whereby it has been observed that learned Judge has not considered the law on the subject and passed the impugned judgment without any justiciable legal basis, such order could not be passed under constitutional mandate in terms of Article 199 of the Constitution of Islamic Republic of Pakistan, 1973, where no legal right has been established in favour of the respondents nor demonstrated in any manner.
 - 10. In view of above, all the captioned appeals are ALLOWED and the impugned order dated 13.04.2011 is hereby SET-ASIDE, The Inspector General of Police as well as Secretary, Ministry of Interior are directed to register the criminal cases against all the officials/employees of Police Department, who have illegally occupied the flats by force with further direction to Inspector General of Police, Islamabad to initiate departmental action against all the occupants on departmental side and shall submit a compliance report before this Court within period of one (01) month, failing which, Secretary Ministry of Interior and Inspector General of Police shall be dealt strictly in accordance with the law.





- 3. Cross border movement mechanism for both pedestrians and cargo has been formalized through border terminals/notified crossing points. All erstwhile traditional routes/illegal crossing points along PAB have been closed. Notified crossing points functional on PAB are as under:-

- (b) whether personnel of railway police or of other law enforcement agencies have been deployed to control the incidents of terrorism on the said tracks?

Mr. Shahid Ashraf Tarar: (a) Duties of officers and subordinate staff of Pakistan Railways i.e. Divisional Executive Engineer, Assistant Executive Engineer, Permanent Way Inspector etc. are primarily the maintenance of track, bridges, points & crossings, station yards, level crossings, cleaning of water ways, railway sidings, replacement of unserviceable track components and de-stressing of welded track. Detail of duties are attached as (Annex-A to D).

(b) As per S.R.O(1)/2016 dated 20.09.2016 (**Annex-E**) issued by the Ministry of Railways, the territorial limits of Pakistan Railway Police are within station limits. While beyond station limits, it is the responsibility of concerned District Police, Levies and FC to control the incidents on railway track. Pakistan Railway Police is deployed in residential colonies, dwelling houses and any other property on the lands belonging to Pakistan Railways within station limits to perform security duty.

However, fence is being installed on the northern side of Margalla Avenue through the Contractor M/s FWO and as of now around 50% length has been fenced to protect CDA's land from encroachment. Agitation and resistance from local populations have been faced at some locations while installing the fence. Efforts are under way to resolve such issues so that the northern side could be fenced in full length.

Dhoke Najju 1-10/4 and Haq Bahou 1-11/4 have been completely relocated in (MUSP) Farash Town by allocating plots each measuring 20'x 40' to the eligible dwellers. Moreover, in Muslim Colony 753 eligible dwellers have been allocated plots in Farash Town.

Minister for Interior: On 16-02-2023, an incident took place at Police Check Post, D-12 as attacked by hardened criminals and two of the assailants were killed in the incident in jurisdiction of Police Station, GoIra. Accordingly, a case FIR No. 88, dated 16-02-2023 U/S 324,353,186,34, PPC and 13/20/65 AO was registered at PS GoIra Sharif, Islamabad. Later on they were found to be persons who committed rape in F-9 park. The previous record of these persons was also found in the record of Islamabad and Punjab. Matter is subjudice in Court of Law.

Minister for States and Frontier Regions: There is no proposal under consideration of the Government to regularize the services of teachers of schools for Afghan Refugees and merge them in the educational institutions of Khyber Pakhtunkhwa on the analogy of teachers of erstwhile FATA, due to the reason that they are UNHCR funded Project employees and are not covered under any prevailing rule for regularization.

Will the Minister for Interior be pleased to state:

- (a) whether the Federal Investigation Agency (FIA) has conducted any investigation, during the last two years, regarding appointment of General Manager (GM), Security in WAPDA and purchase of unauthorized uniforms worth millions of rupees, if so, the details and present status thereof; and
- (b) the steps being taken by the Government to carry out an impartial investigation in the said case indicating also the expected time of completion of the same?

Minister for Interior: (a) Enquiry No. 110/2023 has been registered on 01-08-2023 in FIA / ACC Lahore against Muhammad Tufail, GM Security WAPDA Admin Lahore.

(b) The said Enquiry is registered in this Circle on the allegation that management of WAPDA is involved in irregular appointments and procurement by bypassing PPRA rules and regulations. During the course of enquiry, WAPDA Lahore has been directed to provide the relevant record.

WAPDA has informed that it had conducted an internal enquiry and sufficient evidence evidence to prove these allegations has not been found. FIA Anti-Corruption Circle, Lahore has taken into possession the relevant record through seizure memo. This record is under scrutiny.

As far as procurement of different articles (boots, uniforms etc.) is concerned, relevant record and documents from M/s Nishat Pvt, Ltd. Is awaited. This enquiry will be completed within two weeks' time, after the receipt of this record. The Enquiry is under Probe.

*Question No. 76 **Senator Kamran Murtaza:** (Notice Received on 28/09/2023 at 2:41 PM) QID: 41655

Will the Minister for Interior be pleased to state whether it is a fact that sewerage contaminated water is being supplied by CDA in Sector G-11/1, Islamabad, since 2022 resulting in spread of various disease, if so, the present status of complaints lodged on the issue in the CDA Enquiry office indicating also the reasons for not resolving the issue so far and the time by which the same will be restored?

Minister for Interior: No, CDA is supplying clean drinking water to its consumers in Sectoral Areas and Model Village of Islamabad including in Sub-Sector G-11/1. However, sewerage mixing in few streets occurred due to chocking of Sewerage Line being laid in similar corridor with Water Supply Line which was also laid few decades back. The supply of effected houses was disconnected immediately and till restoration of safe / normal water Supply, the water was supplied to all such consumers through tankers free of cost. Thereafter, on the removal of choking issue the water was once again restored and proper testing was carried out by the water Quality Control Cell CDA (satisfactory reports are placed within the file for ready reference).

*Question No. 77 **Senator Dr. Zarqa Suharwardy Taimur:** (Notice Received on 10/10/2023 at 1:35 PM) QID: 41663

Will the Minister for Interior be pleased to state:

(a) the amount recovered by Federal Investigation Agency (FIA) on currency and dollars smuggling operations in the country during the last three months indicating also the action taken against those found involved in the same; and

(b) whether the said amount has been deposited in the national exchequer, if so, the details thereof?

Minister for Interior: (a) A crackdown against illegal money changers and Hawala/ Hundi operators was initiated to shoulder the activities being conducted at national level to control the devaluation of Pak Rupee.

Smuggling is the mandate of FBR Customs, however, FIA has enhanced profiling and screening of passengers at all international entry/exit points to have an enhanced check to intercept any attempt of currency smuggling through passengers.

Performance of FIA since 1st September 2023 is given below:

Action against illegal money changers Hundi/Hawala since 01-09-2023

- 277 raids have been conducted.
- 281 FIRs have been registered.
- 395 Accused have been arrested.
- 02 shops have been sealed.
- 48 enquiries have been registered out of which 39 have been converted into cases/FIRs.

Following recoveries have been made:

- o USD 417653
- Other Foreign Currencies equivalent to PK:R.163.638 million PKR: 669.451 Million
- o Total recovery in terms of PKR: 954.081 Million
- (b) All the above stated/reported FIRs are at investigation stage, hence no amount has been deposited in National Exchequer with regard to above stated seizures, as seized amount are deposited into National Exchequer after getting it confiscated from Court of Law.

*Question No. 78 **Senator Haji Hidayatullah Khan:** (Notice Received on 12/10/2023 at 11:16 AM) QID: 41664

Will the Minister for Railways be pleased to state whether railway has taken any austerity measures in view of its increasing losses during the last three years, if so, the details thereof?

Mr. Shahid Ashraf Tarar: Pakistan Railways has taken certain austerity measures to moderate its losses. All these austerity measures have been taken in line with the instructions issued by Finance Division from time to time.

In addition to austerity measures, Pakistan Railways has rigorously followed a diversified approach for reducing its different costs alongwith measures to improve its revenue streams. Following plans have been adopted for reducing the costs.

- 1. Electric meters of residential colonies are being shifted to DISCOs. A total of 16535 out of 26,660 have been shifted to DISCOs and K-electric to rationalize its expenditure on utilities. This step has resulted in saving of Rs. 1300 million so far.
- 2. In order to further reduce the electricity bills, Pakistan Railways has prepared a plan to shift on solar energy. The work has initiated by awarding the feasibility study to M/s NESPAK. 100 sites with heavy consumption of electricity have been identified and once shifted to solar energy, it will result in to savings of Rs.1,000 million.
- 3. The present fuel bill for trains exceed Rs.24 Billion per year. Pakistan Railways has planned for automating its Fuel Management System for which EOI was called for in October, 2023. This system is bound to bring better efficiency and operational fuel conservation and it is estimated that about 20% fuel bill will be reduced.
- 4. At present, Pakistan Railways purchases fuel from PSO in bulk and stores the same in its own storage facilities. In order to reduce costs and overheads, Pakistan Railways in collaboration with PSO has decided to handover its storage facilities to PSO and purchase fuel on the spot. On completion, this project is estimated to bring another 10% reduction in fuel costs.

5. The HR strength of Pakistan Railways is being critically analyzed to bring it at a rational level. This step will result in reduction of salary bill and, in the long run, will reduce the overhead of pension payments. 1377 posts from Ministry of Railways, Headquarters office and extra division have been abolished, 720.551 Million per year savings are expected.

In order to improve the revenue streams, certain other steps have also been taken.

- 1. To reduce manual working, streamline financial operations and to minimize risk of ghost employees and pensioners, SAP based ERP system is under development to bring transparency and increase in revenue stream.
- 2. Short term leasing of land has been introduced instead of Long-Term Leasing to stay competitive in the market for increased revenue flow.
- 3. Railways passenger train fares and freight rates have been rationalized and are constantly being monitored based on supply and demand and volatile prices of fuel to generate more revenues.

Pakistan Railways (PR) acknowledges the challenging financial landscape, it has navigated in recent years. The Finances of PR for the past three years reveal a consistent trend of acute shortage in regular expenditures, primarily in areas such as salary, pension, and High Speed Diesel oil (HSD). This shortage has significantly impacted the budget available for addressling other expenses.

Pakistan Railways remains committed to implement cost-cutting measures and revenue optimization strategies to address its financial challenges. The austerity measures undertaken are crucial for the sustainability and financial health of the organization.


