#### **SUMMARY**

The issue was referred by the House to the Standing Committee on Communications on 17<sup>th</sup> June, 2016. It was raised by Senator Lt. General (R) Salahuddin Tirmizi that the FWO is not disbursing payments to the petty contractors even on completion of the work of Mansehra – Naran – Jalkhad road. The contractors are facing hardships because of financial constraints and the act of non-payment on part of the FWO is quite unfair as they are not complying with the payment terms. Notices were issued to the FWO and NHA as it surfaced that the non-payment is owing to the dispute of payments between both the departments. It was explained that Mansehra – Naran – Jalkhad road project spread over 163 kilometers got started in 1997 on special instructions by the then Prime Minister Mian Muhammad Nawaz Sharif. The project stipulated construction of National Highway (N-15) from Mansehra to Chilas via Naran and Babusar.

The project has been completed almost 96.25% and the rest is scheduled to be completed by September, 2016. The delay in payments to the petty contractors is caused because of the non-payment from NHA to FWO thus causing onward problem to the petty contactors. However the FWO authorities produced a letter stating that the payments to the petty contactors have been expedited and within a short span of time, the rest of payments will be made. The NHA owes a huge liability to FWO and despite financial constraints the FWO has paid Rs.567.816 million to the sublet contractors during last three months. The rest of amount will be gradually cleared. It was assured that it will not take more than six months and the payment issue will be resolved. On this assurance the matter was disposed of.

#### RECOMMENDATION

On the assurance of FWO authorities that the petty contractors will be paid the due amount of 744.085 million, the matter was disposed of by the Committee. The Committee also directed that the issue of payments to the petty contractors should not go beyond 31st December, 2016. It was also directed that the NHA should approve the Revised PC-1 and the pending payment be released to FWO by 31st October, 2016. With this timeline the issue was disposed of.
