- The mover of the starred question No.11, Senator Col. ® Syed Tahir Hussain Mashhadi could not attend the meeting. However, the Committee asked the PSO to present its point of view in the matter.
- The MD. PSO briefed the Committee with breakup of sales as per the record which showed that the sale pattern for the month of August, 2012 was consistent and the company did not sell the product to the selected outlets but to all retail outlets as per the established mechanism.
- 6. MD. PSO apprised the Committee that the prices of petroleum products were revised thrice during the month of August, 2012 as per the then policy. The dates when the prices were revised were 15<sup>th</sup>, 21<sup>st</sup> & 30<sup>th</sup> August, 2012 respectively.
- 7. The MD PSO further apprised the Committee that the said matter has also been taken up in the departmental accounts committee of the PSO and will be settled in the light of the record available in due course of time.
