Total number of votes casted were 100, 94 votes were valid and 6 votes were rejected. 50 votes were cast in favour of the resolution whereas 44 votes were cast against the resolution.

So the resolution was not adopted by the votes of a majority of the total membership of the Senate. Consequently the resolution was rejected.

So the resolution was not adopted by the votes of a majority of the total membership of the Senate. Consequently the resolution was rejected.
