REPORT OF THE STANDING COMMITTEE - PRESENTATION OF:

Senator Muhammad Talha Mehmood, Chairman, Standing Committee on Finance, Revenue and Economic Affairs presented report of the Committee on the proposals for making recommendations on the Finance Bill, 2021, containing the Annual Budget Statement.

The Report stood laid.

The Chairman Senate, Leader of the House and the Leader of the Opposition appreciated the hard work by the Committee to finalize the recommendations.

LEGISLATIVE BUSINESS

1. Mr. Ali Muhammad Khan, Minister of State for Parliamentary Affairs on behalf of Senator Dr. Muhammad Farogh Naseem, Minister for Law and Justice, moved that the Bill to provide for the right of review and re-consideration in giving effect to the judgement of the International Court of Justice [The International Court of Justice (Review and Re-consideration) Bill, 2021], as passed by the National Assembly, be taken into consideration.

The Bill was referred to the Standing Committee concerned for consideration and report.

2. Mr. Ali Muhammad Khan, Minister of State for Parliamentary Affairs on behalf of Senator Dr. Muhammad Farogh Naseem, Minister for Law and Justice, moved that the Bill further to amend the Muslim Family Laws Ordinance, 1961 [The Muslim Family Laws (Amendment) Bill, 2021] **(Amendment of Section 4)**, as passed by the National Assembly, be taken into consideration.

The Bill was referred to the Standing Committee concerned for consideration and report.

3. Mr. Ali Muhammad Khan, Minister of State for Parliamentary Affairs on behalf of Senator Dr. Muhammad Farogh Naseem, Minister for Law and Justice, to move that the Bill further to amend the Muslim Family Laws Ordinance, 1961 [The Muslim Family Laws (Amendment) Bill, 2021] **(Amendment of Section 7)**, as passed by the National Assembly, be taken into consideration.

The Bill was referred to the Standing Committee concerned for consideration and report.

Senator Muhammad Talha Mehmood, Chairman, Standing Committee on Finance, Revenue and Economic Affairs, moved that the recommendations on the Finance Bill, 2021, containing the Annual Budget Statement, as reported by the Committee, be adopted.
