MOTION

[Under Rule 263]

1. Senator Sarfaraz Ahmed Bugti, It has been moved under Rule 263 of the Rules of Procedure and Conduct of Business in the Senate,2012, that the requirement of Rules 25, 29, 30 and133 of the said Rules be dispensed with in order to move a resolution to felicitate the Emir of Qatar and the people of Qatar for successfully holding FIFA World Cup.

The Motion was put to the House and Adopted.

RESOLUTION

1. Senator Sarfaraz Ahmed Bugti, moved the following resolution:-

The Senate of Pakistan appreciates the Chairman Senate Muhammad Sadiq Sanjrani's address to 1st Meeting of World People's Consultative Assembly, held in Bandung, Indonesia, from October 24-26, 2022 in which he highlighted various challenges faced by the world in general and Muslim Ummah in particular. Senator Prince Ahmed Umer Ahmedzai, Chairman, Standing Committee on Communications, moved under sub-rule (1) of Rule 194 of the Rules of Procedure and Conduct of Business in the Senate, 2012, that the time for presentation of report of the Committee on a point of public importance raised by Senator Hidayatullah Khan on 17th August, 2022, regarding accidents on the motorway due to non-fencing, may be extended for a period of sixty working days with effect from 15th December, 2022.

BILL TO BE INTRODUCED

1. Senator Mohammad Ishaq Dar, Minister for Finance and Revenue, introduced the Bill to amend the Foreign Investment (Promotion and Protection) Act, 2022 [The Foreign Investment (Promotion and Protection) (Amendment) Bill, 2022].

The Motion was put to the House which was not opposed and leave to introduce the Bill was granted

MOTION

[Under Rule 263]

1. Senator Mohammad Ishaq Dar, Minister for Finance and Revenue, moved under Rule 263 of the Rules of Procedure and Conduct of Business in the Senate, 2012, that the requirements of rules 97, 98 and sub-rule (2) of rule 99 of the said Rules be dispensed with in order to take into consideration at once the Bill to amend the Foreign Investment (Promotion and Protection) Act, 2022 [The Foreign Investment (Promotion and Protection) (Amendment) Bill, 2022].

The Motion was put to the House and Adopted

LEGISLATIVE BUSINESS

2. **Senator Mohammad Ishaq Dar,** Minister for Finance and Revenue, to move that the Bill to amend the Foreign Investment (Promotion and Protection) Act, 2022 [The Foreign Investment (Promotion and Protection) (Amendment) Bill, 2022], be taken into consideration.

The Motion was put to the House and adopted. Thereafter, the House started second reading of the Bill i.e. clause by clause consideration.

3. Senator Mohammad Ishaq Dar, Minister for Finance and Revenue, to move that the Bill to amend the Foreign Investment (Promotion and Protection) Act, 2022 [The Foreign Investment (Promotion and Protection) (Amendment) Bill, 2022], be passed.

The Motion was put to the House and the Bill was passed.

The Bill introduced and referred to Standing Committee concerned.
