Senator Mushtaq Ahmed, on behalf of **Senator Irfan-Ul-Haque Siddiqui,** Chairman, Standing Committee on Federal Education and Professional Training, presented report of the Committee on the Bill to provide for the establishment of Al-Ala University [The Al-Ala University Bill, 2022], introduced by Senators Kauda Babar, Dilawar Khan and Sarfraz Ahmed Bugti on 26th September, 2022.

The Report stood laid.

RESOLUTIONS

1. Senator Samina Mumtaz Zehri, to move the following resolution:-

"Cognizant of the horrific Greece Migrant Boat Disaster leaving hundreds of innocent Pakistani youth die and others displaced in the tragedy;

Mindful of the fact that one of the potential factors behind such human tragedy is the ignorance of common masses who fall an easy prey to local operators and their agents to send their youth abroad through illegal means;

The Senate of Pakistan, therefore, recommends that the government should immediately launch a country wide awareness campaign by using all available communication channels to educate the poor masses about hazards of illegal human trafficking/smuggling abroad and ways to detect/identify and report the local human smugglers under the guise of local operators/ travel agents especially working in rural and backward areas of the country".

The Resolution was deferred

2. Senator Sania Nishtar, moved the following resolution:-

"Recognizing the importance of commemorating World Population Day on 11th July each year, as designated by the United Nations to highlight the significance of population issues;

Acknowledging that the theme for World Population Day 2023 of "Unleashing the power of gender equality: Uplifting the voices of women and girls to unlock our world's infinite possibilities," is particularly relevant for Pakistan and other developing countries where there is an urgent need to prioritize the rights, well-being and empowerment of women and girls;

Showing concern that as the world's fifth most populous country, Pakistan's population is projected to reach 403 million by 2050 which is expected to contribute to challenges such as poverty and unemployment, food scarcity and water crisis, housing shortages, healthcare access and human capital development, depletion of natural resources and environmental degradation;

Observing that the population rise is inextricably linked with women's reproductive health and well-being and often driven by a lack of reproductive rights for women, lack of birth control awareness, child marriages, limited access to education and low female workforce participation;

Acknowledging that by effectively managing the population and empowering women with reproductive rights, Pakistan can unlock the potential of its human capital, improve social indicators and build a prosperous and equitable society;

The Senate of Pakistan, therefore, urges upon the Government to engage in multi-sectoral collaboration, involving all Governmental agencies including Provincial Governments, civil society organizations and relevant stakeholders to work collectively towards achieving sustainable population growth and gender equality".

Abdul Qadir Patel, Minister for National Health Services, responded the issue.

The Resolution passed by the House unanimously.
