RESOLUTIONS

1. Senator Sania Nishtar, moved the following resolution:-

"The Senate of Pakistan commemorates World Humanitarian Day on August 19th and recognizes the selfless efforts of humanitarian workers and organizations who strive to save and protect lives across the globe and to reduce human suffering;

The House also honors those frontline humanitarian workers who have lost their lives in the line of duty;

This House particularly shows appreciation for the humanitarian assistance extended to Pakistan by the global community during last year's devastating floods;

The Senate notes with alarm that humanitarian workers worldwide continue to remain vulnerable to violence and attacks, with major attacks numbering 235 in 2022 alone, including one in Pakistan, undermining the safety and security of those dedicated to saving lives and delivering assistance;

The Senate calls upon the Government of Pakistan to enhance its support for humanitarian efforts, both within its borders and beyond, through diplomatic, financial, and logistical means, in partnership with other governments and multilateral organizations; and

The Senate demands that all governments, including the government of Pakistan enhance measures to provide better security to humanitarian workers."

2. Senator Muhammad Talha Mehmood, moved the following resolution:-

"Expressing its deep concern over the present situation emerging in the areas of Dasu and Diamer Bhasha dams;

This House recommends that:

- 1. the locals should be recruited in the said projects as per the quota fixed for them;
- 2. the salary of persons working in the said projects should not be less than the minimum wages, i. e. Rupees thirty two thousand per month, as fixed by the Government in the budget for current fiscal year;
- 3. the laborers working in those projects should be paid at least Rs. 1500 per day as per Government policy;
- 4. the Government should provide compensation to all the affecttees of those projects under the "chola package";
- 5. The Government should take all necessary steps to utilize the amount allocated for construction of roads, schools and other facilities in the affected areas in consultation with local elders of Kohistan on merit basis;

- 6. necessary funds should be released and work on the Kandia valley road should be expedited and completed at the earliest; and
- 7. the amount fixed for welfare works should be utilized for the welfare of the people of those areas with consultation of local elders and that reasonable demands of the people should be accepted and fulfilled so that the work on those projects may be completed amicably without any hurdle."

AMENDMENTS TO THE SENATE RULES (Under Rule 278)

- **1. Senator Sania Nishtar,** to seek leave under sub-rule (4) of Rule 278 of the Rules of Procedure and Conduct of Business in the Senate, 2012, to move that for Rule 185 of the said Rules the following shall be substituted, namely:-
 - "185. Conflict of interest.- (1) A Chairman or a Member of the Committee shall be personally responsible for submitting a declaration of financial or personal interests or in case of having no such interests, a declaration of having no financial or personal interest in the matters falling within the jurisdiction of the Committee to the Chairman Senate before the first meeting of the Committee, which shall be recorded by the Secretary Senate in the 'Conflict of interest Register'.
 - (2) The declaration of financial interests shall contain the following information, which shall be provided in a precise manner—
 - (a) the Member's occupation or occupations during the three-year period before he or she took up office with the Senate, and his or her membership during that period of any boards or committees of companies, non-governmental organisations, associations or other bodies established in law;
 - (b) any regular remunerated activity which the Member undertakes alongside the exercise of his or her office, whether as an employee or as a self-employed person;
 - (c) membership of any boards or committees of any companies, nongovernmental organisations, associations or other bodies established in law, or any other relevant outside activity that the Member undertakes, whether the membership or activity in question is remunerated or unremunerated;
 - (d) any occasional remunerated outside activity (including writing, lecturing or the provision of expert advice);
 - (e) any holding in any company or partnership, where there are potential public policy implications or where that holding gives the Member significant influence over the affairs of the body in question; and
 - (f) any other financial interests which might influence the performance of the Member's duties.

- (3) The Chairman or a Member of the Committee shall inform the Chairman Senate of any changes that have an influence on their declaration by the end of the month following each change occurring.
- (4) The Chairman or a Member of the Committee who has any personal or pecuniary interest in a matter under consideration of a Committee shall not sit in such meetings of the Committee.
- (5) A Member shall not use his or her position as a Member to influence a decision of another person so as to further the Member's private interests or those of a Member of his or her family, or to improperly further another person's or entity's private interests.
- (6) A Member shall not use information obtained in his or her position as a Member of the Committee that is not generally available to the public to further the Member's private interests or those of a Member of his or her family, or to improperly further another person's or entity's private interests."
