- I. Further consideration of a Privilege Motion moved by Senators Naseeb Ullah Khan Bazai and Sardar Muhamad Shafiq Tareen against the President, National Bank of Pakistan on the following allegation:
"That a meeting of the Senate Special Committee on the problems of the employees of the National Bank of Pakistan belonging to Balochistan was scheduled to be held on 12th October, 2023 at 12:00 noon at NBP Head Office at Karachi. However, the meeting was delayed for 40 minutes due to absence of the President NBP while he was present in his office within the same building and even after passage of 40 minutes he did not appear before the Committee due to which the meeting was postponed. The behavior of the President NBP was unprofessional and non-serious towards the Committee which also reflects his non-seriousness towards the resolution of the grievances of the employees of NBP belonging to Balochistan. Due to deliberate absence of the President NBP the privilege of the Committee has been breached."
- II. Consideration of a Privilege Motion moved by Senators Saleem Mandviwalla, Faisal Saleem Rehman and Syed Sabir Shah against the Director General, Civil Aviation Authority (CAA) for giving false assurances to the sub-committee of the Senate Standing Committee on Aviation constituted to examine and make recommendations for resolution of the issue of revocation/suspension of licenses of pilots.
