- v. Briefing by PEIRA on the Registration and De-registration of private schools and regulatory measures regarding the collection of unauthorized funds/charges from students.
- vi. Final discussion on the report of the Sub-Committee regarding the agenda referred by Senator Rana Mahmood-Ul-Hassan concerning the functioning, transparency, financial management, selection criteria, third-party evaluation mechanism, and performance outcomes of the National Vocational and Technical Training Commission (NAVITC) during the past five years.
- vii. Review of the implementation status of the recommendations adopted by the Committee in its previous meeting, including actions taken thereon and any pending matters requiring further implementation. Any other item with the permission of the Chair.
