A meeting of the Senate Standing Committee on Housing and Works will be held on Wednesday, the 22<sup>nd</sup> July, 2026 at 11 a.m. in Old PIPS Hall (PRC Hall), Parliament Lodges, Islamabad. In case of Senate session in the morning, the meeting will be held at 2:30 p.m.

2. **The agenda of the meeting is appended below:-**

- (1) Report by the Secretary M/o. Housing & Works on the following issues of the Maintenance Staff of former Pak PWD:
  - (i) Total number pending cases since 2018 of the Pak PWD Maintenance employees who died during service and their families have not yet been given financial assistance and other benefits admissible under the 2014<sup>th</sup> Prime Minister's Assistance Package for the in-service death of employees, giving details of date of death of the employee and the reasons for non-payment and delay in each case and surrender/lapse of the funds/budgetary allocation for this purpose in Financial Year 2025-26.
  - (ii) Reasons for not processing and forwarding to the AGPR by the DG Pak PWD, the cases for payment of retirement related benefits including pension, gratuity, leave encashment, T.A. etc. to those Pak PWD Maintenance employees who were retired on or before 30-6-2025 when they were on the payroll of Pak PWD. The details of officers responsible for this grave negligence and utter defiance of the Federal Cabinet decision may be provided.
  - (iii) Details of employees who have not been transferred to or accepted by any department and the reasons thereof.
  - (iv) Department wise details of employees who have not been paid salaries and salary arrears till now and the reasons thereof.
  - (v) Details of the departments which have been allowing in-service benefits including different types of paid leave, house rent, GP Fund, medical treatment facility/reimbursement of medical expenses, overtime, grants including marriage, disability, etc. **and retirement related benefits** including pension, GP Fund, etc. and the department-wise number of beneficiaries.
  - (vi) Details of the departments which have not paid/refused in-service and retirement related benefits as mentioned in agenda (v) above and the reasons thereof – whereas it is a fact that pensions had long been granted under earlier orders and OMs, with over 10,000 cases processed and budgetary allocations made annually.
  - (vii) Final report/decision of the committee constituted on the issue of payment of pension, GP Fund, etc. to these employees.
- (2) The Secretary M/o. Interior, Chairman CDA, Secretary Finance Division and the AGPR to explain reasons for **non-implementation on the Federal Cabinet decision** (as notified by the M/o. Housing & Works vide Notification dated 6<sup>th</sup> Sept. 2024) by not allowing in-service as well as retirement related benefits as mentioned in agenda (v) above.
- (3) The Secretary M/o. Interior and the Chairman CDA may explain reasons for **non-implementation on the Wafaqi Mohtasib (Ombudsman)'s recommendations dated 31-3-2026 (issued on 6-4-2026) in Complaint No.WMS-HQR/0001481/26 & 21 Others** whereby the Secretary, M/o. Interior was directed "to issue immediate directions, being the administrative Ministry and Principal Accounting Officer, to CDA and other concerned quarters for expeditious finalization of the pension cases of the complainants, ensuring payment without any further delay.....Compliance be reported within 45 days..."

- (4) Briefing by the Chairman CDA on current status of the replacement and repair works of 5 lifts at the Shaheed-e-Millat Secretariat.
  - (5) Detailed briefing by the Director General FGEHA on the current status of Green Enclave-I including details of land acquisition, allotments made, reasons for delay and the efforts being made to complete the project. (Discussed in the Committee meetings held on 15-9-2025 and 29-4-2026).
  - (6) Any other matter(s) with permission of the Chair.
