i. **Briefing by Administrator, Islamabad Club on the following:**

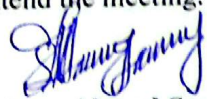
- a. Audited financial statements for the last three financial years, including details of revenue, expenditure, surplus or deficit, outstanding liabilities, receivables, investments and major audit observations, along with the action taken thereon.
- b. Details of development, renovation and maintenance projects undertaken during the last three years, including their approved and revised costs, completion timelines, present status and reasons for any delay or cost escalation.
- c. Details of land, buildings and other assets under the Club's possession or management, including their legal status, present utilization, encroachments, unauthorized occupation and measures taken to safeguard public property.
- d. Details of income generated from membership fees, restaurants, guest rooms, sports facilities, events and other commercial activities during the last three years, together with their operating costs and profitability.
- e. Details of disciplinary proceedings, inquiries, litigation and complaints involving the Club, its management or employees during the last three years, along with their present status.

ii. **Briefing by Managing Director, Public Procurement Regulatory Authority (PPRA) on the following:**

- a. What is the current adoption/compliance rate of EPADS 2.0 across federal procuring agencies, and what enforcement exists against non-compliant agencies?
- b. How is PPRA ensuring uniform application of the Public Procurement Rules and the new Disposal of Public Assets Regulations, across federal entities?
- c. What progress has been made in harmonizing PPRA's regulations and standard bidding documents with provincial procurement authorities (Punjab, Sindh, KP, Balochistan)?
- d. Legal basis, approving authority, scope and duration of any relaxation or exemption granted for the procurement of fuel and other essential goods in view of the ongoing conflict in the Middle East. PPRA shall clarify whether the procurement was authorized under the emergency procurement provisions or through an exemption of the PPRA Ordinance, and provide:
 - i. Copies of the relevant approval, notification, exemption or order;
 - ii. The complete list of goods, services and procuring agencies covered;
 - iii. The effective date and duration of the relaxation or exemption; and
 - iv. The safeguards instituted to prevent misuse, overpricing, favoritism and post-emergency continuation of the relaxation.

iii. Any other item (s) with the permission of the Chair.
