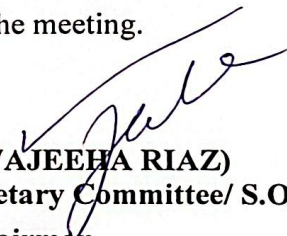
REVISED NOTICE

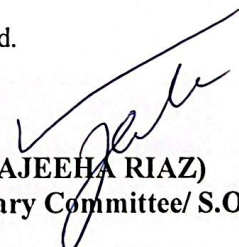
